1. The above Financial results have been reviewed by the Audit Committee and approved by the Board of Directors at their meetings held on August 13, 2026 respectively. The statutory auditors of the Company have reviewed the financial result for the quarter ended June 30, 2026, in terms of Regulations 33 of SEBI (Listing and Other Disclosure Requirements) Regulations, 2015.

2. As informed earlier, the subsidiary Company at Singapore viz. Readymade Steel Singapore Pte. Ltd., is under liquidation process and hence due to non-availability of its financial information, the same have not been considered in the above consolidated financial results. The Company in its standalone financials has already impaired its investments and loans outstanding in the said subsidiary. In view of the same, there will be no material impact of the said liquidation on the financials of the Company. These results consolidate the financial statements of two of the subsidiaries viz. Kridhan Infra solutions Ltd. & Kridhan Media Tech Private Ltd. (effective from 12th Jan 2026).

3. The Company operates in a single business segment but there are two geographical segments. However since the figures for Singapore subsidiaries are not available as mentioned above, the segment reporting is not submitted.

4. *Since the Company has already impaired its investments and loans outstanding in the said Associate Company viz. Vijay Nirman Company Private Limited, in its consolidated financials, there is no impact in the current consolidated financials and hence not considered in the results.

5. Exceptional Items are on account of Reversals of earlier provisions for Loans & Advances.

6. The Company has undertaken various initiatives to strengthen its financial position and improve its business prospects. The recent preferential allotment of equity shares and/or warrants is expected to augment the Company's equity base and provide additional financial resources to support the expansion of its business activities. The Company has accumulated losses over the past years, resulting in erosion of its net worth. However, considering the improvement expected from its business prospects, proposed diversification and expansion of operations, the Management is confident of the Company's ability to continue its operations as a going concern. Accordingly, these financial results have been prepared on a going concern basis.

2 The above Audited financial results for the Quarter ended 30th.June,2026 were reviewed by the Audit Committee and thereafter, approved by the Board of Directors and was taken on record at their meeting held on August 13, 2026. The Statutory Auditors of the Company have conducted limited review on the above financial results for the quarter ended 30th.June,2026.						
3 An Interim Dividend @ 25% (25 paise on the face value of Re. 1) has been approved by the Board of Directors at its aforesaid Meeting.						
4 As per the Joint Sector Agreement (hereinafter referred to as "JSA") dated 23-Feb-90 executed between The National Insulated Cable Company of India Limited (known as Nicco Corporation Limited, hereinafter referred to as NCL, under liquidation), West Bengal Tourism Development Corporation Limited (hereinafter referred to as "WBTDCL") and West Bengal Industrial Development Corporation Limited (hereinafter referred to as "WBIDCL"), the Company's land on which the Amusement Park and F&B & Other Recreational Operations are being carried out was made available to the Company for a period of 33 years on lease with renewal clause of two more terms of similar period. Pursuant to liquidation proceedings against NCL, shares of the Company held by them has been transferred and thereby, the JSA as specified therein has become infructuous and inoperative. Moreover, the first tenure of the lease of 33 years vide agreement dated 05-Jul-91 between Governor of the State of West Bengal and the Company had expired on 28-Feb-23. Necessary application for the renewal of lease agreement has been made with Department of Tourism, Government of West Bengal vide letter dated 11-Oct-22, is pending to be executed as on this date. Pending this, and finalisation of the terms and conditions thereof, the provision for the fees and charges as estimated by the management applying its own judgement for possible enhancement following the prudent principle of accounting has continued to be made in these financial results. Further, such fees and charges as agreed upon in terms of the earlier agreement, have been continued to be paid. As stated by the management, the application for renewal is under active consideration and in principle approval in this respect has been given by Government of West Bengal, and lease is expected to be renewed. Accordingly, operations and related arrangements have been considered as ongoing as per the terms and conditions provided in the above agreement and required provisions including for depreciation etc. has been recognised and the financial results have been continued to be prepared on Going Concern Basis.						
5 The Department of Tourism, Government of West Bengal ("State Government"), vide communication issued during the previous year and pursuant to a unilateral decision, reposessed with effect from 08-Nov-25 certain parcels of land aggregating approximately 1.46 acres, earlier utilized by the Company for its "F&B and Other Recreational Facilities" segment under the existing lease/ operational arrangements with the State Government. The repossession and transition of operations was effected prior to completion/ formalization thereof under the original lease arrangements with the company. Pending renewal of the lease as stated in Note 4 above, and formalization of the above arrangement, the Company, in the interest of continuity of public operations and customer services, has continued to undertake and manage such operations on behalf of the WBTDCL. Accordingly, management and supervision charges amounting to Rs. 5.48 Lakhs (Previous Year ended 31-Mar-26: Rs. 31.10 Lakhs) for the quarter ended 30-Jun-26 have been recognized under Other Income. Further, expenditure incurred and/ or allocated in connection with the aforesaid F&B and Other Recreational Facilities operations has been recovered on an ongoing basis from WBTDCL. The Company is in discussion with the concerned Government authorities/ entities and has also made a representation to the State Government regarding the status of the operation currently being undertaken in absence of any formal agreement to the effect. The decision in this respect is awaited as on this date and consequential adjustments, if any, shall be effected on determination.						
6 The Government of India vide notification dated 21-Nov-25 has notified the Code on Wages, 2019, the Industrial Relations Code, 2020, the Code on Social Security, 2020, and the Occupational Safety, Health and Working Conditions Code, 2020 (collectively referred to as "the Labour Code") consolidating and replacing the then existing multiple labour legislations in the country. Consequently, the potential impact on the employee benefit and expenses on account of past service costs amounting to Rs. 47.02 lakhs as evaluated and determined by an independent actuary or otherwise as estimated had been recognized and disclosed as employee benefit expenses in the financial statements for the year ended 31-Mar-26. Further, the provision pertaining to the quarter ended 30-Jun-26 as estimated has been recognized during the period. The developments and further clarifications in this respect are being continued to be monitored and consequential further adjustments will be given effect to on determination in subsequent period.
