Virat Kohli bowls to Rohit Sharma during training ahead of India vs Australia Nagpur Test



New Delhi. India and Australia have hired plenty of net bowlers to train for the much-anticipated Border-Gavaskar Trophy Test series. While Australia were training in Alur, on the outskirts of Bengaluru, they hired Baroda off-spinner Mahesh Pithiya who had a similar style to that of R Ashwin while India also used the services of the likes of Jayant Yadav to prepare for the Nathan Lyon threat. As it turned out, Virat Kohli was rolling his arm over to his captain Rohit Sharma on the eve of the 1st Test in Nagpur. It was not the center-pitch training but as the players were warming up for training, Kohli was seen bowling his medium-pace to Rohit beside the training pitches at the Vidarba Cricket Association Stadium in Nagpur. Fans, who were at the stadium, to watch the stars train for the first Test captured the moment where Kohli was taking short bowling strides and offering medium-pace training to Rohit. It was good to see the camaraderie between the former captain and the current captain as fans rejoiced the heartwarming moment from India's training on Wednesday. Notably, it was Rohit Sharma's first Test match against Australia at home and his first high-profile Test series at home as captain. Rohit will be under the scanner as the skipper missed as many as 5 out of 7 Tests due to injuries and illness last year. The skipper went through a lean patch but he overcame it by scoring his 30th ODI hundred against New Zealand in a recently-concluded 3-match series at home. Rohit was in superior form last time he played a high-profile series at home. The opener was able to negate the spin threat from England in 2021, scoring 345 runs, including a hundred, in 4 Tests.

Out or not out? Mark Waugh, Ravi Shastri weigh in on Usman Khawaja LBW review in Nagpur Test

New Delhi. Former Australia batter Mark Waugh said on Thursday, February 9 that he wasn't sure whether the ball-tracker got it right after Usman Khawaja was adjudged LBW on Day 1 of the first Test of the Border-Gavaskar Trophy series in Nagpur. Khawaja was given not out by on-field Nitin Menon but India took the DRS after a long discussion and overturned the decision successfully. Usman Khawaja was out for 1 as early as the 2nd over as Mohammed Siraj struck with his first delivery of the Test match. Siraj got the ball to swing into the left-handed batter and trapped him LBW. Siraj went for a huge appeal but the umpire Menon was unmoved. Rohit Sharma, who was fielding at mid-on, rushed to debutant wicketkeeper-batter KS Bharat to consult him before taking the DRS. As Siraj remained persistent, Rohit took the DRS with just a second left on the 15-second countdown clock. While it looked like it was touch and go to the naked eye, the ball-tracking showed that the ball pitched in line and swung enough to hit the leg-stump. It was 3 reds as Usman Khawaja had to walk back to the dressing room. The Australian support staff in the dressing room looked

surprised by the ball-tracking that was showcased with the replays. Had it not been three reds and the ball just clipped the leg-stump, Khawaja would have not been out as the umpire's call would have stayed. However, the ball tracking showed that the ball went on to hit the middle of the leg-stump. Speaking to the host broadcasters, former batter Mark Waugh said Usman Khawaja might feel unlucky after the DRS review went against him in the first session in Nagpur. "I thought it was maybe sliding down leg-stump or, at best, clipping leg-stump. But I think, the Indians thought the same. They took until the last second to take the review." "I thought it might have clipping, but the HawkEye said it was hitting the middle of leg-stump. I am not sure it was. Anyway, that was the first one down, a bit unlucky for Khawaja," he added.

SHASTRI'S TAKE ON DRS CALL
Questions were asked about the ball-tracking system by a section of Australian cricket fans on social media after Khawaja walked away for 1 with disappointment. Australia were rattled at the start as they were reduced to 2 for 2 after Mohammed Shami got David Warner out bowled for 1.



However, Steve Smith and Marnus Labuschagne steadied the ship with an 82-run partnership before Ravindra Jadeja ran riot after the lunch break. Jadeja removed Labuschagne for 49 before getting Matt Renshaw for a first-ball duck. Speaking about the Khawaja LBW dismissal, former India head coach Ravi Shastri said: "Yes, it looked as if it would have clipped leg-stump. When you saw it from upstairs, anyone would have said it was clipping leg-stump. But the ball-tracking said it hit the leg-stump. India will be very happy with that review. Sometimes, as a batter, you get the rough end of the stick, I think Khawaja got one there," Shastri said.

Border-Gavaskar trophy: My journey has never skyrocketed, says KS Bharat about emotional India Test debut

KS Bharat opened up on his journey to the Indian team and said it was all about small steps. Bharat was handed his Test cap on Thursday ahead of the first Test against Australia in the Border-Gavaskar Trophy.

New Delhi. KS Bharat has said that his journey to the Indian team was all about small steps and it never skyrocketed at any point after being handed his Test debut in the first match of the Border-Gavaskar trophy in Nagpur. Bharat was selected ahead of Ishan Kishan in the lineup and was handed his Test cap by veteran Cheteshwar Pujara in Nagpur

on Thursday morning. In a video released on BCCI's official website, the wicketkeeper said it was a proud moment for him and paid tribute to his family, friends and coaches over the years. "It was a lot of joy to go back over the years from where it all started. Coming all the way long here and watching my jersey. It's a very proud moment, lots of emotions. It is not just my dream, do many people have dreamt about me playing for India and doing well for India." "So much of hard work behind me, a lot of support strength over the years right from my teammates, my family, my wife, my parents, my friends, coaches. Without their support, it wouldn't have been possible for me to share this stage today," said Bharat. I think a lot of credit goes to them for putting in all they had behind me and making me reach where I am today." Bharat also paid



tribute to his coach, Jayakrishna Rao, who first said he had the potential to represent India. The 29-year-old said that he realized his true calling when he started preparing for the big challenges and said that the lean patch he endured in his career helped him realize that he had some potential to make it. "When I started playing first class, I never thought of this day to be very honest. It was

my coach, Jayakrishna Rao. Credit to him. He believed I had the potential right when I wasn't believing it. In U-19, he told me I had the potential to keep wickets for India. At that time, I felt, fine, that's a long way away. Who knows what's going to happen the next day? This is him talking about five six years from now." "There was an element that I have the passion for the sport. But whether I would make it to that level was still a question mark. Later, when we started working on my keeping, batting, when we started preparing for unknown challenges, it is when I enjoyed cricket more. For me to believe that I had potential to play for India, it took me four or five years of continuous performances. The first three years I had brilliant seasons, then I had a lean patch. And when I had a lean patch and bounced back, it is when I realized.

संपादकीय

बुलेट ट्रेनचा मार्ग मोकळा
