# Ex-rapper's party set for landslide win

Rapper-turned-politician **Balendra Shah's** newly formed Rastriya Swatantra Party (RSP) was on Friday heading for a landslide victory in Nepal's first general election

since the violent Gen Z protests toppled the KP Sharma Oli-led government in September.

According to data released by the Election Commission from 144 of the total 185 constituencies, the RSP has won three seats and is leading in 104 others, media reported.

The Nepal Congress has won two seats and is leading in 12

others, while the Communist Party of Nepal-United Marxist-Leninist (CPN-UML) is leading in 10 constituencies.

The Nepal Communist Party has won one seat and is leading in six constituencies. The opposition is expected to provide a strong government in politically fragile Nepal, which has 14 governments in 18 years.

The election was being closely watched by India. "We look forward to working with the new Government of Nepal to further build on the robust multifaceted ties between our two countries and peoples for mutual benefit," PMA Spokesperson

Randhir Jaiswal said in Delhi. Biskendra Shah, who was the mayor of Kathmandu till recently, is leading in Jhapa-5 constituency against four-time PM and CPN-UML chair KP Sharma Oli in the latter's stronghold. Shah, aka Balen, received 6,551 votes while Oli got 1,428 votes. Banju Dandana of the RSP won from Kathmandu-15 with 15,455 votes, while Yogesh Gauchan Thakali of the Nepal Congress won from

M Mustang with 3,307 votes. As per an official, Puspika Kamal Dahal Prachanda won from Rukum Purba district with 10,240 votes against his nearest rival Lilamani Gautam of CPN-UML, who got 3,482 votes.

# Cuba is soon going to fall, says POTUS

Washington: US President Donald Trump on Friday morning said that Cuba "is going to fall pretty soon," CNN reported.

"Cuba is gonna fall pretty soon, by the way, unrelated, but Cuba is gonna fall soon. We want to make a deal so badly," he told CNN in a telephone interview when touting US military success in his second term. "They want to make a deal, and so I'm going to put Marco (Rubio) over there and we'll see how that works out. We're really focused on one thing now. We've got plenty of time, but Cuba's ready - after 50 years," he said, explaining that the priority is to get a deal. "We've been watching it for 50 years, it's fallen right into my lap because of its fall, but it's nevertheless fallen right into the lap."
