-किशनगंज व धामनोद पुलिस मामले की जांच कर रही है -प्रेमी के बाद पत्नी की भी साली के सामने ही हत्या कर दी

महू। किशनगंज थाना क्षेत्र में एक पति ने अपनी पत्नी और उसके प्रेमी की हत्या कर दी। आरोपी संजय भूरिया खरगोन जिले के बबलई गांव का रहने वाला है। उसकी पत्नी लक्ष्मी धामनोद के ग्राम कुंदा की निवासी थी। दोनों किराए के मकान में रहे थे।

संजय को अपनी पत्नी और महेश नामक युवक के बीच संबंधों का पता चला। उसने पहले महेश की किशनगंज क्षेत्र में हत्या की। इसके बाद उसने पत्नी को भी मारा-पीटा। घायल पत्नी की जानकारी उसने धामनोद स्थित ससुराल में दी। संजय अपनी घायल पत्नी को महेश की मोटरसाइकिल पर बांधकर धामनोद की ओर ले जा रहा था। रास्ते में पत्नी की बहन ने उन्हें देखा। वह भी मोटरसाइकिल पर बैठ गई और बहन को छोड़ने की मिनतें करने लगी। उसने डॉक्टर के पास ले जाने की गुहार लगाई, क्योंकि तब तक लक्ष्मी की सांसें चल रही थीं। लेकिन संजय नहीं माना। गुजरी गद्दी फाटे के पास ईंट भट्टों के नजदीक उसने पत्नी की हत्या कर दी। फिर पत्नी का शव और साली को सड़क किनारे फेंक दिया। साली की चीखों से आसपास के ग्रामीण जमा हो गए। उन्होंने पुलिस को सूचना दी। धामनोद पुलिस ने शव को अस्पताल भेजा, जहां 23 वर्षीय लक्ष्मी का पोस्टमार्टम किया गया। वारदात के बाद संजय सीधे महेश्वर थाने पहुंचा और

सरेंडर कर दिया। एक नजर में घटना- किशनगंज थाना क्षेत्र में सोमवार को प्रेम प्रसंग के विवाद ने दो जिंदगियां छीन लीं। पुलिस के अनुसार, बंजारी निवासी संजय ने पहले अपनी पत्नी के प्रेमी की हत्या की और फिर पत्नी की जान भी ले ली। वारदात के बाद आरोपी महेश्वर थाने पहुंचकर आत्मसमर्पण कर दिया। पुलिस जांच में सामने आया कि संजय की पत्नी लक्ष्मी का महेश नामक युवक से प्रेम संबंध था। इसकी भनक लगते ही संजय ने हत्या की योजना बनाई। पहले उसने किशनगंज क्षेत्र में महेश की हत्या की और फिर पत्नी को मारते-पीटते हुए धार

जिले के धामनोद थाना क्षेत्र के गुजरी गांव तक ले आया। वहां गद्दी रोड पर भट्टे के पास उसकी हत्या कर शव सड़क पर फेंक दिया। धामनोद थाना प्रभारी प्रवीण ठाकरे ने बताया कि सूचना मिलने पर पुलिस मौके पर पहुंची और शव को कब्जे में लेकर जांच शुरू की। इस बीच, महेश्वर पुलिस ने आरोपी को गिरफ्तार कर किशनगंज पुलिस के सुपुर्द कर दिया।

गुजरी में मिला महिला का शव- महेश की हत्या के बाद आरोपी पत्नी को लेकर गुजरी पहुंचा और वहां उसकी हत्या कर शव सड़क किनारे फेंक दिया। पुलिस ने मौके से सबूत जुटाए और मामले की जांच जारी है।
