Even as India and the United Kingdom are all set to ink on Thursday a landmark Free Trade Agreement (FTA), a move expected to unlock billions in trade and investment opportunities for both nations, the Congress on Wednesday claimed that serious questions have emerged on its impact on India's domestic in-

HOW INDIA BENEFITS

Nearly 99% of Indian goods sent to the UK will now enjoy zero-duty access. This will eliminate existing tariffs that range from 4% to 16%, especially benefiting sectors like textiles, leather, footwear, toys, marine products, gems and jewellery, and engineering goods, including auto components and electric vehicles.

Indian workers in the UK will no longer have to contribute to UK social security for a period of up to three vears. This move is expected to save Indian workers and companies around Rs 4,000 crore every year.

Chefs, yoga instructors, musicians, and other contractual workers will now get temporary access to the UK job market, giving a boost to India's services sector.

HOW UK GAINS FROM FTA

The Free Trade Agreement brings significant advantages for the UK, especially through reduced tariffs on its key exports. Tariffs on 90% of UK goods will be removed, giving a strong boost to sectors like whisky, gin, automobiles, and food items. For example, the current 150% tariffs on Scotch whisky and gin will gradually drop to 75%, and then to 40% over ten years. Similarly, car tariffs will fall from 100% to just 10%. Products like cosmetics, chocolates, biscuits, salmon, and medical devices will also get tariff relief, making them more competitive in the Indian market.

UK manufacturers in sectors like machinery, aerospace, and automobiles are expected to benefit significantly. Big brands such as Jaguar Land Rover, Aston Martin, and Diageo are likely to see increased exports. British consumers may also benefit from lower prices on Indian imports, including both goods and services.

The deal also provides UK companies greater access to Indian government contracts. Under the FTA, British firms can bid for Indian non-sensitive government tenders worth over Rs 2 billion. This opens up access to around 40,000 tenders annually, valued at Rs 4.09 lakh crore.

US claims at UNSC of de-escalating **Indo-Pak Conflict**; India affirms it was resolved bilaterally

The United States brought to the Security Council President Donald Trump's claim of having resolved the India-Pakistan conflict in May, but New Delhi reaffirmed that it was resolved bilaterally.

Acting US Representative Dorothy Shea listed on Tuesday the conflict between India and Pakistan following the terrorist massacre in Pahalgam by The Resistance Front as one of those de-escalated by "US leadership" in the last three months, repeating an assertion Trump has made often.

"The United States, under President Trump's leadership, played an important role in encouraging the parties to reach these resolutions, which we applaud and support", she

India's Permanent Representative P Harish said firmly that it was "directly concluded" at Pakistan's request to India.

Operation Sindoor "on achieving its primary objectives, a cessation of military activities was directly concluded at the request of Pakis-

Harish said that Operation Sindoor, launched in retaliation for the massacre of 26 people by The Resistance Front, an offshoot of Lashkare-Tayiba based in and backed by Pakistan, "was focused, measured, and non-escalatory in nature".

The operation was motivated by the Council statement on "the need to hold perpetrators, organisers, financiers and sponsors" of the Pahalgam attack accountable, and it targeted terrorist camps in Pakistan and Pakistan-occupied Jammu and Kashmir, he said.

The BJP Rajya Sabha MP and former Haryana BJP chief Subhash Barala's son Vikas Barala has been appointed as Assistant Advocate General (AAG) in Haryana at the Advocate General (AG) Delhi office.

The case was registered on the complaint on Varnika and trial in the case is pending before a Chandigarh court with the next hearing in the case being August 2, 2025. Vikas is currently out on bail. According to the complain-

ant, she was heading to her home in Chandigarh on August 4 night when she noticed a car following her and its occupants, Vikas and Anish allegedly attempted to block her path and tried to enter her vehicle.

Initially the Chandigarh police booked them under Section 354D (stalking) of the IPC and relevant sections of the Motor Vehicles Act, though subsequently, charges of attempting to abduct her were added after widespread criticism of police functioning.

The Chandigarh court framed charges against the duo on October 13, 2017 and Vikas remained in jail for about five months and appeared in his law exams during the period.

According to media reports, Vikas's appointment was recommended by a screening committee comprising two retired judges of the high court. The order regarding his appointment was Vikas and his friend **Ashish Kumar were** booked on August 5, in 2017 for allegedly stalking and attempting to kidnap RJ Varnika Kundu, daughter of a senior IAS officer VS Kundu (now retired)
