अफवाह निकली झेलम एक्सप्रेस में बम की सूचना

मोपाल, (निप्र)। झेलम एक्सप्रेस में बम रखने की खबर अफवाह निकली। रेलवे और जिला प्रशासन की टीमों ने मोपाल में देन की सर्जिंग की, इसके बाद उसे रवाना कर दिया गया। मोपाल होकर जाने वाली झेलम एक्सप्रेस देन के एन-9 कोच में बम रखे होने की सूचना के बाद हड़कप मग गये। बम होने की जानकारी एन-9 कोच में यात्रा करने वाले एक युवक दी। इसके बाद यात्रियों को दहशत फैल गई। तत्काल इस्पाती सूचना गिआरपी को दी गई। जानकारी के अनुसार झेलम एक्सप्रेस तुक्कार सुबह साढ़े 8 बजे की जगह पर रात्रे 9 बजे रानी कमलावती स्टेशन पर पहुंची तो जीआरपी, आरपीएफ के साथ बम डिपोजल और डींग खोजों की टीम ने पूरे कोच को घेर लिया। सभी यात्रियों को बाहर निकाला गया। इसके बाद करीब एक घंटे तक पूरी देन की बारीकी से जांच की गई। जांच में किसी भी कोच में कोई भी सख्ति वस्तु नहीं पाई गई, इसके बाद एन-9 कोच में बैठे उस युवक को आरपीएफ ने हिरासत में ले लिया। जिसमें बम होने की सूचना दी थी। आरोपी से पूछताछ की जा रही है।
