Pursuant to Regulation 30 read with Part A of Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, read with SEBI Master Circular dated 11<sup>th</sup> November, 2024, we hereby inform that the company had allotted 94,61,480 (Ninety-Four Lakhs Sixty One Thousand Four Hundred and Eighty) convertible warrants, each convertible into equity shares of face value of Rs. 1/- each, ("Warrants") at an issue price of Rs. 158.50 per warrant, ("Warrant Issue Price") preferential basis to Promoter/Promoter Group.

Out of the aforesaid warrants, the warrant holder(s) of 63,69,000 warrants did not exercise the option to convert the said warrants into equity shares within the stipulated period of 18 months from the date of allotment, i.e. on or before 26<sup>th</sup> January, 2026. Accordingly, the said warrants have lapsed and stand cancelled, and no equity shares have been allotted pursuant thereto.

Further, in accordance with the provisions of the SEBI (Issue of Capital and Disclosure Requirements) Regulations, 2018, the upfront amount equivalent to 25% of the issue price per warrant, aggregating to Rs. 25,23,71,625/-, paid at the time of allotment of the said warrants, stands forfeited by the Company.
