Sub:- Intimation of Disclosure on receipt of Order from the Income Tax Department under Regulation 30 of SEBI (Listing Obligations & Disclosure Requirements) Regulations, 2015 - reg.

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, this is to inform that the Company's Appeal against the Income Tax demand for the Assessment Year 2023-24 has been decided in favour of the Company, vide order dated 08th April, 2026.

The Income Tax Authorities had earlier raised a demand of Rs.69,58,75,410/- primarily on account of disallowance of exemption claimed on Agricultural Income. The Hon'ble Appellate Authority has now allowed the Company's claim, treating the said income as agricultural income, thereby setting aside the aforesaid demand.

This is in continuation of our earlier disclosure dated 27th March 2025, wherein the Company had informed about receipt of the demand notice and its intention to pursue appropriate legal remedies.

The details as required under SEBI Circular are enclosed as **Annexure I**.
