To consider and approve the alteration of Memorandum of Association of the Company.</p>	<p>Members are hereby informed that:</p> <ol style="list-style-type: none"> The Cut-off date for the purpose of ascertaining the eligibility of members to cast their vote through remote e-voting facility is Friday, May 12, 2023. The Company has engaged the services of National Securities Depository Limited (NSDL) for providing e-voting facility to shareholders. The members whose names appear in the register of members/register of beneficial owners as on the Cut-off date shall only be entitled to use the remote e-voting facility. A person who is not a member as on the Cut-off date should treat this Notice for information purposes only. In compliance of statutory provisions, the Company has completed the dispatch of Postal Ballot Notice only through e-mail. On Monday, May 22, 2023, to those shareholders whose e-mail IDs are registered with the Company Depositories and whose names appear in the register of members/register of beneficial owners as on the Cut-off date. Further, physical copy of Notice along with explanatory statement and Postal ballot form has not been sent to the members for this Postal ballot. Hence, the members are required to communicate their assent/dissent only through remote e-voting system. The remote e-voting period shall commence on Tuesday, May 23, 2023 (09:00 AM IST) and will end on Wednesday, June 21, 2023 (05:00 PM IST). The remote e-voting module will be disabled thereafter by NSDL. Once the vote on a resolution is cast by a Member, they shall not be allowed to change it subsequently to cast the vote again. The detailed procedure/instructions for e-voting are specified in the Notice to the Postal Ballot Notice. The Board of Directors of the Company has appointed Ronak Juthawot & Co., Practising Company Secretary (Certificate of Practice no. 12084) as a Scrutinizer for conducting this Postal Ballot process.
