Dear Sir/Madam,

With reference to the captioned subject and the recent communication received from the Exchange, we wish to provide the following update and clarification regarding the **"Diluted EPS mentioned in Standalone and Consolidated XBRL is incorrect"** for the period ended September 30, 2025."

- 1. Prior Clarification:** We would like to bring to your kind attention that the Company had previously submitted a clarification letter dated January 27, 2026 (Copy Attached), explaining that the **Basic EPS is identical to the Diluted EPS for the said period on both a Standalone and Consolidated basis.** We had noted that the omission was due to a typographical error and requested the Exchange to allow us the opportunity for re-work.
- 2. Permission to Re-work:** Since we did not receive the re-work permission following our previous submission, the discrepancy remained pending on the Exchange's records.
- 3. Corrective Action Taken:** In response to your most recent notice and to ensure immediate compliance, we have now proactively revised the Integrated Governance Finance (XBRL) for the period ended September 30, 2025, and submitted the same on the NEAPS portal within the prescribed timeline.
- 4. Confirmation of Data:** We hereby confirm that the "Diluted EPS" in the revised XBRL filing now reflects the figures as per the signed Financial Results previously submitted to the Exchange.
- 5. Outcome of Board Meeting: The outcome:** The outcome of board meeting has been filed within thirty (30) minutes from the closure of the meeting of the board of directors on October 15, 2025 at 12:38 p.m. where as the meeting was closed at 12:25 p.m.
