Notes

- 1 These Unaudited Financial Results ("the Statement") for the quarter ended 30th June, 2026 were reviewed by the Audit Committee and approved by the Board of Directors of the Company at the meeting held on 5th August, 2026.
- 2 This Statement is as per Regulation 33 of the Securities and Exchange Board of India ("SEBI") (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("Listing Regulations").
- 3 The Company is primarily engaged in one business segment namely Footwear as determined by the Chief Operating Decision Maker (CODM) in accordance with Ind AS 108 - Operating Segments.
- 4 On 21st November, 2025, the Government of India notified four Labour Codes - the Code on Wages, 2019, the Industrial Relations Code, 2020, the Code on Social Security, 2020, and the Occupational Safety, Health and Working Conditions Code, 2020 - consolidating 29 existing labour laws. Subsequently, on 8th May, 2026, the Ministry of Labour & Employment notified the respective Central Rules under the four Labour Codes, namely, the Code on Wages (Central) Rules, 2026, the Industrial Relations (Central) Rules, 2026, the Social Security (Central) Rules, 2026 and the Occupational Safety, Health and Working Conditions (Central) Rules, 2026. The Company has assessed and disclosed the incremental impact of these changes on the basis of best information available, consistent with the guidance provided by the Institute of Chartered Accountants of India. Considering the materiality and regulatory-driven, non-recurring nature of this impact, the Company has presented such incremental impact as "Statutory impact of new Labour Codes" under "Exceptional Items" in the audited Financial Results for the quarter and year ended 31st March, 2026. Further, in the State of West Bengal, the Labour Department published draft rules for objections/suggestions and are yet to be finally notified. The Company continues to monitor the finalisation of State Rules and clarifications from the Government on other aspects of the Labour Code and would provide appropriate accounting effect on the basis of such developments as needed.
- 5 The Company does not have any subsidiary/associate/joint venture entity(ies) for the quarter ended 30th June, 2026.
- 6 Previous years'/period's figures have been regrouped/rearranged wherever necessary.
- 7 The Statutory Auditors of the Company have carried out a Limited Review of the Statements, as required under Regulation 33 of the SEBI Listing Regulations and the related Report does not have any impact on the above 'Results and Notes' for the quarter ended 30th June 2026 which needs to be explained.
- 8 The unaudited financial results will be posted on the website of the Company (www.ksrfootwear.com) and will be available on website of NSE and BSE.

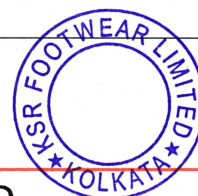
