Collector reviews Rs. 158 cr projects

Tiruvannamalai, Sept 17: Collector Vandana Garg on Wednesday inspected two major projects worth Rs. 158 crore and reviewed monsoon preparedness across Tiruvannamalai taluk under the 'Ungalai Thedi Ungal Ooril' programme. She inspected the Rs. 53 crore Tamil Cultural Centre under construction at Athiyandal and directed officials to ensure quality and expedite the work. The two-storey centre, coming up on 55,800 sqft, will showcase ancient Tamil culture and the state's heritage. Garg also reviewed the Rs. 105 crore underground sewerage and sewage treatment project on Manalurpet Road and instructed officials to speed up works ahead of the monsoon.

At Vengikkal lake, she reviewed restoration and stormwater drainage arrangements. She also inspected drains and canals at Jay Bhim Nagar, Gandhi Nagar and other vulnerable areas and directed officials to ensure free flow of rainwater.

Later, the Collector distributed welfare assistance worth Rs 19.73 lakh to 112 beneficiaries, including house-site pattas, patta transfers, financial assistance, ration cards and agriculture and horticulture benefits. She also received 114 petitions from the public.



Greater Chennai Corporation Commissioner G.S. Sameeran held discussions with Hiralaksha Tattuki, Second Secretary (Environment), Embassy of Japan in New Delhi, on solid waste management initiatives being implemented by the Corporation, at Ripon Buildings in Chennai.



Perungudi Zonal Monitoring Officer Maheshwari Ravikumar chaired a review meeting on North-East monsoon preparedness at the Perungudi zonal office in Chennai on Wednesday. Zonal Officer N. Sridevi and officials from Greater Chennai Corporation, Chennai Metrowater, Tamil Nadu Electricity Department, Chennai Metro Rail Limited, Tamil Nadu Road Development Company and Highways Department participated.

GCC fines 120 bulk waste generators Rs 6.6 lakh

Chennai,ept 17: Greater Chennai Corporation (GCC) has collected Rs 6.60 lakh in fines from 120 Bulk Waste Generators (BWGs) for violating Solid Waste Management Rules, 2026, over the past 40 days and warned that continued violations could invite further enforcement action. The civic body said all BWGs in the city must mandatorily register with both the GCC and Central Pollution Control Board (CPCB) portals and comply with source-segregation and waste-processing norms. Around 90% of BWGs in GCC limits have already registered, while the remaining establishments have been directed to complete registration immediately. Under the rules, establishments are classified as BWGs if they have a built-up area of 20,000 sqm or more, consume at least 40,000 litres of water a day, or generate 100 kg or more of solid waste daily. Corporate offices, commercial establishments, residential welfare associations, hotels, hospitals, educational institutions, IT parks, marriage halls, malls, markets and factories can fall under the category. Violators face fines ranging from Rs 5,000 to Rs 25,000. The GCC said authorities have also been

empowered to act against non-compliant BWGs following a Supreme Court order dated May 25, 2026. BWGs must segregate waste at source using colour-coded bins — green for biodegradable waste, blue for non-biodegradable and recyclable waste, red for sanitary waste and black for domestic hazardous or special-care waste. They must process wet waste within their premises through composting, biogas production or other approved eco-friendly methods. Dry, sanitary and hazardous waste should be handed over separately to the GCC or its authorised agencies. BWGs are also required to maintain records of waste generation, processing, transportation and final disposal and submit details every three months through the GCC and CPCB portals. Staff and Swachh Bharat Mission campaigners appointed by Zonal Officers across the city's 15 zones, along with independent engineers, will assist establishments with the registration process. BWGs can register on the GCC portal at www.chennaicorporation.gov.in and on the CPCB portal at <https://swm.cpcb.gov.in/register>. More details are available on the GCC website.
