Opinion

- 1. We have jointly audited the accompanying Standalone Financial Results of The Karnataka Bank Limited (the "Bank") for the quarter and year ended March 31, 2025 ("the Statement") attached herewith, being submitted by the Bank pursuant to the requirements of Regulation 33 and Regulation 52 read with Regulation 63(2) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("LODR Regulations") except for the disclosures relating to Pillar 3 disclosure as at March 31, 2025 including Leverage Ratio, Liquidity Coverage Ratio and Net Stable Funding Ratio under Basel III Capital Regulations as have been disclosed on the Bank's website and in respect of which a link has been provided in the Standalone Financial Results and have not been audited by us.

 - ii. gives a true and fair view in conformity with the recognition and measurement principles laid down in the applicable accounting standards, prescribed under Section 133 of the Companies Act 2013 (the "Act") read with the Companies (Accounting Standards) Rules, 2021 to the extent applicable, the relevant provisions of the Banking Regulation Act, 1949, circulars, directions and guidelines issued by the Reserve Bank of India (RBI) from time to time ("the RBI guidelines") and other accounting principles generally accepted in India, of the net profit for the quarter ended March 31, 2025 as well as the year to date results for the period from April 1, 2024 to March 31, 2025 and also the Standalone Statement of Assets and Liabilities as at March 31, 2025 and the Standalone Statement of Cashflows for the year ended on that date.

Emphasis of Matter

4. We draw attention to Note 14 of the Standalone Financial Results, which states that the total expenditure includes an amount of ₹1.16 crore incurred in connection with engaging consultants & other revenue expenditure and total fixed assets include capital expenditure amounting to ₹0.37 crore, which were incurred beyond the delegated powers of the whole-time directors and was not ratified by the Board. Consequently, the said amount is recoverable from the concerned directors. However, no effect has been given in the accounts in respect of the recoverable amount. Our opinion is not modified in respect of this matter.

Management and Board of Directors' Responsibility for the Standalone Financial Results

5. These Standalone Financial Results have been compiled from the annual standalone financial statements which are approved by the Board of Directors. The Management and Bank's Board of Directors are responsible for the preparation of these Standalone Financial Results that gives a true and fair view of the net profit, the Standalone Statement of Assets and Liabilities and the Standalone Statement of Cashflows in accordance with the recognition and measurement principles laid down in Accounting Standards prescribed under Section 133 of the Act read with relevant rules issued thereunder, the relevant provisions of the Banking Regulation Act, 1949, the circulars, guidelines and directions issued by the Reserve Bank of India (RBI) from time to time ("RBI Guidelines") and other accounting principles generally accepted in India and in compliance with Regulation 33 and Regulation 52 read with Regulation 63(2) of the LODR Regulations. This responsibility also includes maintenance of adequate accounting records in accordance with the provisions of the Banking Regulations Act, 1949 for safeguarding of the assets of the Bank and for preventing and detecting frauds and other irregularities; selection and application of appropriate accounting policies; making judgments and estimates that are reasonable and prudent; and design, implementation and maintenance of adequate internal financial controls that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of the Standalone Financial Results that give a true and fair view and are free from material misstatement, whether due to fraud or error.

In preparing the Standalone Financial Results, the Board of Directors and management are responsible for assessing the Bank's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the Management and Board of Directors either intends to liquidate the Bank or to cease operations, or has no realistic alternative but to do so.

The Management and Board of Directors of the Bank are also responsible for overseeing the financial reporting process of the Bank.

Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Bank to cease to continue as a going concern.
- Evaluate the overall presentation, structure, and content of the Standalone Financial Results, including the disclosures, and whether the Standalone Financial Results represent the underlying transactions and events in a manner that achieves fair presentation.
- 8. We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.
- 9. We also provide those charged with governance with a statement that we have complied with relevant ethical requirements regarding independence, and to communicate with them all relationships and other matters that may reasonably be thought to bear on our independence, and where applicable, related safeguards.

Other Matters

- 10. The Standalone Financial Results for the quarter ended March 31, 2025 being the balancing figure between the audited figures in respect of the year ended March 31, 2025 and the published unaudited year to date figures up to the third quarter of the current financial year which were subject to limited review by us.
- 11. The Standalone Financial Results of the Bank for the year ended March 31, 2024 were jointly audited by Kalyaniwalla & Mistry LLP, Ravi Rajan & Co. LLP and Sundaram & Srinivasan, Chartered Accountants, who vide their audit report dated May 24, 2024, expressed an unmodified opinion on those standalone financial results. Accordingly, R.G.N. Price & Co., Chartered Accountants, do not express any opinion on the figures reported for the year ended March 31, 2024 in the Standalone Financial Results.

Our opinion on the Standalone Financial Results is not modified in respect of above matters.



NOTES FORMING PART OF THE AUDITED STANDALONE AND CONSOLIDATED FINANCIAL RESULTS FOR THE QUARTER AND YEAR ENDED MARCH 31, 2025.

1. The above Standalone and Consolidated financial results ('the financial results') for the quarter and year ended March 31, 2025 have been reviewed by the Audit Committee of the Board at the meeting held on May 13, 2025 and recommended for approval to and approved by the Board of Directors at meeting held on May 14, 2025. The same has been subjected to audit by the Joint Statutory Auditors of the Bank M/s Ravi Rajan & Co. LLP, Chartered Accountants and M/s RGN Price & Co., Chartered Accountants in line with the guidelines issued by the Reserve Bank of India and as per the requirements of The Securities and Exchange Board of India (Listing Obligations & Disclosure Requirements) Regulations, 2015, who have issued an unmodified opinion on the same.

The financial results for the quarter and year ended March 31, 2024 were reviewed/audited by the Joint Statutory Auditors, M/s Sundaram & Srinivasan, Chartered Accountants, M/s Kalyaniwalla & Mistry LLP, Chartered Accountants and M/s Ravi Rajan & Co. LLP, Chartered Accountants.

- 2. These Standalone and Consolidated Financial Results have been prepared in accordance with the Accounting Standards prescribed under section 133 of the Companies Act, 2013 read with relevant rules issued thereunder, the relevant provisions of the Banking Regulation Act, 1949, the circulars, guidelines and directions issued by Reserve Bank of India ("RBI"), from time to time ('RBI Guidelines') and other accounting principles generally accepted in India, and is in compliance with the presentation and disclosure requirements of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ('SEBI LODR').
- 3. The Consolidated Financial results of the Group comprise of the audited financial results of The Karnataka Bank Ltd (the Bank) and its wholly owned subsidiary -KBL Services Ltd.
- 4. In the preparation of these Standalone and Consolidated financial results for the year ended March 31, 2025, the Bank has followed the same significant accounting policies and generally accepted practices as adopted in the preparation of audited Standalone and Consolidated financial statements for the year ended March 31st 2024, except for i.

hassification and valuation of Investment as per master direction issued by RBI dated 12th





September 2023, applicable from 1st April 2024; ii. Provision for certain category of accounts, over and above the regulatory norms not considered during the year as the same was assessed as not required at this point of time; iii. in case of recoveries in non-performing Overdraft Accounts whereby the recoveries are first appropriated towards interest and then towards charges and excess allowed in overdraft account if any, followed by expired sanctioned TOD, vis-a-vis earlier policy whereby it was first appropriated towards excess allowed in overdraft account if any, followed by expired sanctioned TOD and then towards interest. However, the impact, is immaterial.

The investments of the Bank as at April 01, 2024 have been re-classified and valued in accordance with the requirements of the above-mentioned Master Directions and transitional adjustments on account of 'Available For Sale' (AFS) portfolio and other securities has been credited to "AFS Reserve" and opening "Revenue Reserve" to the extent of ₹ 106.88 crore and ₹ 24.68 crore, respectively.

Further, in Compliance with the Master Directions, the valuation gains and losses at the year ended March 31, 2025 across all performing investments, irrespective of classification (i.e., Government securities, Other approved securities, Bonds and Debentures, etc.), held under AFS is aggregated and the net gain of ₹35.80 crore (net of taxes) for the year (₹ 11 crore (net of taxes) for the quarter) has been directly credited to AFS reserve. The securities held in Fair Value through Profit and Loss ('FVTPL') and Held for Trade ('HFT') are fair valued as at the year end and the revaluation gain (net) arising on such valuation has been credited to the Profit and Loss amounting to ₹2.23 crore. All investment purchased and sold during the year ended March 31, 2025 are done in compliance with the requirement of the Master Directions and revised accounting policy.

Hence, the corresponding previous year ended March 31, 2024, figures are not comparable. Had the Bank continued to follow the earlier accounting policy, "interest income on investments" would have been lower by $\stackrel{?}{_{\sim}}$ 21.56 crore for the year ($\stackrel{?}{_{\sim}}$ 2.31 crore for the quarter), "Other Income" would have been higher by $\stackrel{?}{_{\sim}}$ 169.07 crore for the year ($\stackrel{?}{_{\sim}}$ 49.18 crore for the quarter) and "Profit before Tax" would have been higher by $\stackrel{?}{_{\sim}}$ 147.51 crore for the year ($\stackrel{?}{_{\sim}}$ 46.87 crore for the quarter).










- 5. The Standalone and Consolidated financial results have been arrived at after considering the provisions on the basis of extant guidelines / directives issued by The Reserve Bank of India on Advances, Restructured Accounts, Non-Performing Assets, exposure to entities with Un-Hedged Foreign Currency, Non Performing Investments and fair valuation on Investments, provision for employees' retirement benefits like pension, gratuity, leave encashment and unused sick leave as per actuarial valuations, Income Tax and other usual and necessary provisions on estimates.
- 6. Other income includes fees earned from providing services to customers, commission from non-fund based banking activities, earnings from foreign exchange and derivative transactions, selling of third-party products, profit on sale of investments (net), MTM on Investments under FVTPL/HFT, recovery in written-off accounts etc.

- 10. Provision Coverage Ratio as at March 31st 2025, stood at 81.42% (79.22% as at March 31, 2024).
- 11. During the quarter ended March 31, 2025, the Bank has allotted 42,193 equity shares (6,86,704 equity shares during the year ended March 31, 2025) of face value of ₹ 10/- each, pursuant to the exercise of Employee Stock Options Scheme.
- 12. The Board of Directors of the Bank have proposed a dividend of ₹ 5 per Equity share of ₹ 10/- each (50% of Equity share Capital) for the year ended March 31, 2025 (Previous year ₹. 5.50 per Equity share of ₹. 10 each), subject to the approval of the members at the ensuing Annual General Meeting. In terms of Accounting Standard (AS) 4 Contingencies and Events occurring after the Balance Sheet date, the Bank has not appropriated proposed dividend aggregating to ₹ 188.97 crore from the Profit and loss account for the year ended March 31, 2025. However, the effect of the proposed dividend has been reckoned in determining capital funds in the computation of Capital adequacy ratio as on March 31, 2025.
- 13. During the last quarter of FY 2024-25, certain suspicious UPI Global transactions were found on account of erroneous identification of some of the transactions as "failed". This identification resulted in reversal of amount to the customer accounts.

The matter was informed to Reserve Bank of India (RBI) on 17th February 2025 and to the stock exchanges and the Bank has also suspended the transactions in UPI Global. As per the RBI letter dated 19th March, 2025, Bank has adhered to the instructions inter-alia including forensic audit by an external agency, report of which is awaited.

The Bank has initiated necessary actions towards recovery of the amount involved, duly following the procedures of filing FIR and other available legal recourses.

The impact on account of the above at ₹ 18.87 crore is fully provided for. The Bank does not envisage any further adverse impact on this account as the Bank has suspended transactions in UPI Global as stated above.

14. Total expenditure includes expenditure incurred in connection with engaging consultants

and other revenue expenditure amounting to ₹ 1.16 Crore and Total Fixed Assets include
