KEY BUSINESS HIGHLIGHTS



Strong Revenue Growth With Margin Expansion

Net Sales grew 14.1% YoY to ₹546.3 Mn in H1FY26, supported by sustained demand and improved market traction.

Sequentially, revenue improved 8.6% HoH, reflecting consistent business momentum.

Significant Improvement in Profitability

EBITDA grew 25.6% YoY to ₹92.6 Mn, reflecting strong operating leverage and disciplined cost control.

EBITDA margin expanded by 155 bps YoY to 17.0%, driven by improved efficiencies, better productivity PAT grew 25.3% YoY to ₹45.1 Mn, with PAT margin improving 74 bps YoY to 8.3%.

The company remains focused on strengthening product portfolio, improving operational efficiencies, & driving profitable scale-up in the coming periods.

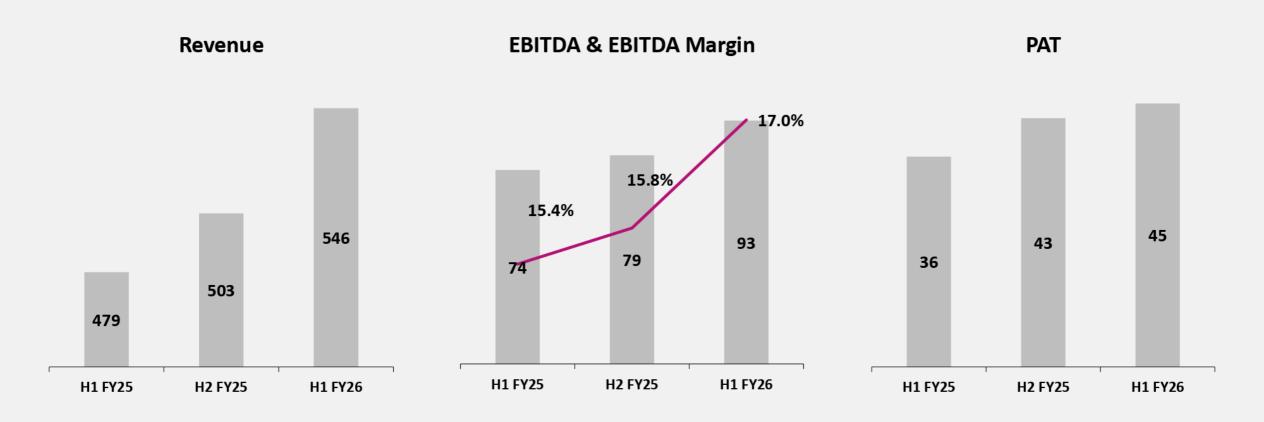
