Background of dispute/litigation: Litigation was instituted by Lakshya Powertech Limited (Plaintiff) for Non-payment by Devi Engineering & Construction Limited (Defendant) in connection with services rendered

We are pleased to inform you that the Commercial Court, Ahmedabad, in the matter of dispute with M/s Devi Engineering & Construction Limited (Hereinafter referred to as “**Defendant**”), has vide its order dated February 19, 2026 pronounced the decision in favour of the Company. With this decision, the Court has ordered that the Defendant –

1. to pay the principal amount i.e., **Rs. 2,06,12,630/- (Rupees Two Crore Six Lakh Twelve Thousand Six Hundred Thirty Only)** along with simple interest at the rate 24% p.a. on the principal amount from the date of filing of the suit till its realization to the company; and
2. shall pay the costs of the suit to the company and bear its own costs of the suit.
