1. Must belong to a Hindu and Karuneeagar caste.
2. Must be at least 25 years old.
3. Must not be an undischarged insolvent.
4. Must not be a lunatic or suffer from an incurable disease that renders them unfit for work.
5. Must not have been convicted of an offense involving moral turpitude.
6. Must be employed in Madras or reside within 32.19 kilometers (20 miles) of the Trust office.

Application Process
As per the Original Side Rules of the Hon'ble Madras High Court, interested candidates must submit their applications before the Hon'ble Madras High Court on or before 30.06.2025, along with the following documents:
• Affidavit filed by any two Karuneeagar members in support of the proposed Trustee's name.
• Community Certificate / Transfer Certificate (TC) as proof of caste.
• Vakalat and Judge's Summons to be filed along with the affidavit.
• Proof of residence and relevant experience.
• Any additional supporting documents establishing eligibility.
The selection of new Trustees will be conducted in accordance with the Scheme Decree and in the best interest of the Trust's objectives. The decision of the Hon'ble Justice of the Madras High Court will be final and binding.
