CO.APPL. 643/2021 & CO.APPL. 626/2022

1. These applications have been filed by *P.S. Security Services (P) Ltd.* for directions to the Official Liquidator ('**OL**') seeking release of the amounts in favour of *P.S. Security Services (P) Ltd.*
2. Counsel for OL states that the amount of *Rs. 2,43,42,192/-*, as verified, be disbursed from common pool fund towards the security agency bills, subject to reimbursement of the same along with interest @ 9% from common pool fund.
3. In terms of this written submission of OL, these applications are allowed to this extent.
4. Applications stand disposed of accordingly.

CO.APPL. 332/2025

1. This application has been filed on behalf of OL seeking sanction or acceptance of the sale of movable assets of the Company [in liquidation] in favour of *Cenet Buildwell Private Limited*, the Auction Purchaser, with respect to the Fibre Optic Cables in Delhi & NCR and Mumbai.
2. In view of the facts stated in the application, the application stands allowed.
