Palaniswami slams Coimbatore Master Plan, alleges scope for "massive irregularities"

Chennai, Aug 28: Leader of Opposition in the Tamil Nadu Assembly and AIADMK General Secretary Edappadi K. Palaniswami on Wednesday strongly criticised the DMK government's Coimbatore Master Plan 2041, alleging it was flawed, opaque, and designed to benefit ruling party-linked interests.

In a statement, Palaniswami said the plan had created "shock and apprehension" among Coimbatore residents, warning that it could open the door to "scientific corruption on a large scale."

Prepared by the Directorate

of Town and Country Planning, the master plan spans 1,531 sq km, covering the Coimbatore City Municipal Corporation, four municipalities, 21 town panchayats, and 66 revenue villages. It outlines land use for agriculture, housing, industries, and other development.

The AIADMK leader charged that the exercise was rushed through without transparency. He pointed out that the mandatory public hearing was "abruptly halted midway," yet the plan was pushed forward despite "serious shortcomings" and lack of clarity. Palaniswami alleged that companies

linked to ruling party families would benefit disproportionately by manipulating land use and zoning rules, potentially involving nearly 50,000 acres and irregularities worth thousands of crores.

"This scheme appears deliberately structured to serve vested interests while harming farmers, landowners, and genuine development needs," he said, demanding an immediate review and redefinition of the plan.

He asserted that the AIADMK would oppose the master plan in its present form and "stand with the people of Coimbatore to prevent large-scale irregularities."

Kauvery performs innovative heart surgery

Chennai, Aug 28: Kauvery Hospital has become the first in South India to perform a Transcatheter Edge-to-Edge Repair (TEER) of the mitral valve using MyClip, India's first indigenously developed device. The landmark procedure was carried out in June on a 65-year-old woman with severe mitral valve leakage who was unfit for open-heart surgery.

Through a minimally invasive approach, doctors successfully

implanted the clip via the groin, significantly reducing valve leakage. The patient recovered well and was discharged within 72 hours.

Mitral valve leakage often leads to heart failure, with surgery being the only option until now. TEER offers a safer, non-surgical alternative for high-risk patients, improving survival and quality of life.

"This case demonstrates the potential of TEER using MyClip

for patients unsuitable for surgery, serving as a bridge to recovery or transplant," said Dr R. Anantharaman, Senior Interventional Cardiologist.

"Our mission is to bring world-class, minimally invasive cardiac care to India. This success gives new hope to those battling advanced heart failure," added Dr. Aravindan Selvaraj, Co-Founder & Executive Director, Kauvery Hospitals.

FIR filed against Vijay over Madurai conference incident

Madurai, Aug 28: In fresh trouble for actor-turned-politician and Tamilaga Vettri Kazhagam (TVK) president Vijay, the Tamil Nadu police have registered an FIR against him and a few bouncers after a young fan was allegedly thrown off the ramp during the party's second state conference near Madurai on August 21.

The incident took place as Vijay

walked along a ramp to greet supporters. Despite grease being applied on the railings to prevent fans from climbing up, a youth, Sarath Kumar, managed to jump on and rush toward the actor with another fan. They were intercepted by Vijay's bouncers, who tossed Sarath into the crowd, leaving him injured.

Visuals of the incident quickly went viral, sparking widespread

criticism on social media.

Based on a complaint from Sarath Kumar, a native of Kunnam, police initially booked the case at Kunnam, Perambalur district, under Sections 189(2), 296(B), and 115(1) of the BNS—provisions relating to manhandling and abetment of a serious offence. The case has since been transferred to Madurai, where the incident occurred.
