Tuesday, 2nd September 2025, Mumbai – Landmark Lifestyle Cars Private Limited, a wholly owned subsidiary of Landmark Cars Limited (BSE: 543714 | NSE: LANDMARK), a leading premium automotive retail network in India, has received a letter of intent from Stellantis Automobiles India Private Limited for the sale and after sale business of the Citroën car brand in Delhi, leveraging their existing Jeep showroom at Mathura Road and workshop in Okhla. The arrangement, consistent with the previously executed bespoke agreement with the OEM for Mumbai territory, reflects Landmark's disciplined strategy of optimizing infrastructure to deliver higher efficiency and growth and deepening brand / regional presence.

Further, as part of their consolidation strategy, Landmark will discontinue operations at their Jeep showroom in Moti Nagar, Delhi. Given that the location has been in operation for several years and is substantially depreciated, this move will have marginal financial impact. The step is aligned with Landmark's long-term goal to rationalise costs and streamline operations to reinforce its profitable growth journey.
