In accordance with SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and Code of Practices and Procedures for Fair Disclosure of Unpublished Price Sensitive Information in terms of Regulation 8 of SEBI (Prohibition of Insider Trading) Regulations, 2015, the following is our business update for the quarter ended September 30, 2025 (“the period”):

1. The consolidated total revenue from operations for the period are as below:

\* The proforma revenue from operations above includes the revenue from sale of cars through Mercedes-Benz cars under agency model. Under the agency agreement, customers now place orders through company directly to MBIL on which LCL and LCEPL earns commission on each sale of Mercedes-Benz cars.

2. The company posted a strong growth of 30% plus YoY, its fastest growth in a quarter ever post listing backed by outlet additions in the previous year and strong demand in the Navratra period. The government made an announcement of reduction in GST rates mid-August which was to be implemented from 22 Sept’25. The growth was achieved even though many purchases were postponed during the above period. The reduction of GST on all ICE cars is a pathbreaking measure which bodes well for the revival of demand on a sustained basis.

3. In July 2025, the company operationalised two KIA workshops in Hyderabad and started the Mercedes-Benz operations in Patna. These outlets have started contributing positively and the impact will be seen through the year. In October 2025, the company also operationalised the Kolkata outlet for MG Select. The brand has received a positive response.
4. In After sales, the company is targeting to reach its historic growth rate in current financial year. The new workshops which have recently started operations have started contributing to the volumes. This is the highest ever quarterly after-sales revenue posted by the company.
5. The company has started strengthening its partnership with Mahindra and Mahindra with planned opening of a sales outlet in Hyderabad. Separately, the company is opening small sales outlets of KIA in Hyderabad and Kolkata. All these outlets are expected to be operational in November.
