1. The consolidated total revenue from operations for the period are as below:

* The proforma revenue from operations above includes the revenue from sale of cars through Mercedes-Benz cars under agency model. Under the agency agreement, customers now place orders through company directly to MBIL on which LCL and LCEPL earns commission on each sale of Mercedes-Benz cars.

2. GST reforms have had a positive influence on the auto industry.
3. The Company reported highest ever quarterly proforma revenue from operations. This robust YoY growth was slightly impacted due to temporary supply chain constraints in BYD cars, which normalized in January 2026. The demand for BYD cars continues to be strong.

4. Supported by the ramp-up and stabilization of workshops, the aftersales business achieved a new quarterly high, with YoY growth outperforming the last five quarters.
5. In the current quarter, the Company has operationalised the M&M showroom in Hyderabad. Further, the Mercedes-Benz showroom in Bhopal is expected to be operationalized in January 2026.
6. For CY2026 multiple high-profile model launches are planned by partner OEMS, including the Mahindra XUV 7XO, Mahindra XEV 9S, the new-generation Kia Seltos, and the new Renault Duster. The delivery of these models is expected to start in the March Quarter and drive healthy sales momentum in the coming months. Mercedes Benz is likely to launch 12 new models in 2026.
7. The Company is in the process of evaluating the impact of the new Labor Code based on the guidelines provided by ICAI.
