Hope this email finds you in good health.

I am having a tough time managing my health especially my persisting back issue and hence I am writing the present email.

Like I have already informed you in my previous email, I am having an extensive skin disease in my hip and a severe back pain issue, because of which I am in constant pain.

Never thought that all this will happen to me but it seems that long and stressful working hours in the company have finally made an ever lasting impact on my health.

Add to this, my Diabetes problem, because of which my blood sugar levels are constantly fluctuating.

All this is not helping me at all in taking care of my daily routine tasks including my official assignments.

My recent visit to my doctor has made matters worse. He has advised me the following:

- A. No long working hours
- B. No sitting job
- C. No travel

Compiling the above information, I can not continue in the company anymore.

I quit – due to my personal reasons - both as a co-founder and also as a Consultant.
