Subject: Disclosure under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with Para A(20) of Part A of Schedule III thereto for Addictive Learning Technology Limited (the “Company”)

Dear Sir/Madam,

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“LODR Regulations”) read with Para A(20) of Part A of Schedule III thereto, we wish to disclose that the Company has received a notice from the National Stock Exchange of India (the “Exchange”) for the imposition of a fine with respect to the delay in filing an application for the no-objection of the stock exchange for reclassification request of a promoter.

The Company maintains that the reclassification request in question was not compliant with the requirements of Regulation 31A(3)(b) of LODR Regulations and accordingly, the Company was not required to make an application to the Exchange for the no-objection. Hence, the Company will be applying to the Exchange for a waiver / review of the said fine in accordance with the Exchange's Policy for Waiver of Fines and explore the possibility of an appeal before the Securities Appellate Tribunal, if required.

The details of the fine as required to be provided under Para A(20) of Part A of Schedule III of the LODR Regulations have been provided as Annexure A.
