The letter of resignation received from Mr. Shivratn Shrigopal Mundada is enclosed as **Annexure B**.

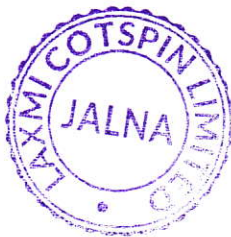


