Ministry of Corporate Affairs, Government of India vide Gazette Notification dated 28/2/2017 issued rules to amend the Investor Education and Protection Fund Authority (Accounting, Audit, Transfer and Refund) Rules, 2016 which came into force w.e.f. 28/2/17.

2. As per the stated Rules, the dividend which has not been unpaid or unclaimed for a period of seven years need to be transferred to IEPF along with the shares held against that name.
