Subsequent to above Tax Adjustments, on June 19, 2026, the Department levied penalty of INR 8,23,53,445 under section 271(1)(c) of the Income Tax Act, 1961.

The company believes it has very strong case as similar penalty proceedings have already been decided in favour of the Company by ITAT FY 2002-03, 2003-04 and 2006-07.
