30 devotees injured in stampede like situation inside Sri Jagannath temple

Puri (Odisha), Nov 10 (UNI) : At least 30 devotees, mostly elderly women habisyals, sustained injuries following a stampede-like situation inside Sri Jagannath temple during the Mangal arati darshan of the Trinity on Friday. One Habisyal sustained a severe injury on her leg and is being treated in the district headquarters hospital.

According to sources, a large number of

devotees including habisyals were waiting at Simhadwar, the main entrance to the temple in the morning.

When they were allowed there was heavy rush as the general devotees also entered the temple. At Inside temple inner space known as 'Kumbhabdha' while devotees were entering through Sat Pahach (seven steps door) and Ghanit dvar, the two doors to the main temple,

there was a stampede like situation because of heavy rush.

Many Habisyals fell down, scores of others experienced severe suffocation and fell unconscious with profusely vomiting.

Temple security and police shifted them to an air conditioned temple office room and provided ORS drink before escorting them to district headquarters hospital in phases.

Both houses of Bihar Legislature adjourned sine die

Patna, Nov 10 (UNI) : The winter session of both houses of Bihar Legislature were adjourned sine die on Friday. During the session which started on November 6, both Houses had five sittings.

Assembly Speaker Awadh Bihari Chaudhary and Chairman of Legislative Council Divesh Chandra Thakur adjourned the respective houses sine die after completing the scheduled business of the day. The Speaker and the Chairman expressed their gratitude to the legislators

for extending their cooperation in transacting scheduled business during the session.

They also expressed gratitude to media for coverage of proceedings of both the houses.

Report of socio-economic caste survey recently conducted by Bihar government, was tabled in both the houses.

Chief Minister Nitish Kumar during his speech after the debate on socio-economic caste survey in both the houses on Tuesday had triggered major controversy by his remark against women, while appreciating the fall of population growth following increased education level among girls.

He, had, however withdrawn his remark on November 8 and apologised to women for hurting their sentiments. Bihar government proposed new reservation formula, in the light of report of caste survey, increasing the upper reservation limit of various categories in government services to 75

percent from existing 60 percent.

As per the new reservation formula, SCs would be given 20 percent reservation, STs would get 2 percent, OBCs would get 43 percent while poor among upper castes would continue to get 10 percent reservation in government services, as earlier. Important bills including Bihar Reservation of posts against vacancies (for SCs, STs and OBCs) Amendment Bill 2023, Bihar Reservation (in government educational institutions) Amendment Bill 2023,

Bihar Goods and Service Tax (second amendment) Bill 2023, Bihar Sachivalaya Service (Amendment) Bill 2023, and Bihar Panchayat Raj (Amendment) Bill 2023 were passed in both the houses of Bihar Legislature. The second supplementary budget and related Appropriation Bill for the financial year 2023-24 was also passed in both the houses of legislature.

Sikkim CM condes demise of Kamala Devi

Gangtok, Nov 10 (UNI) : Sikkim Chief Minister PS Tamang on Friday condoned the death of Kamala Devi, wife of former state Governor Ganga Prasad. Humiliation of Jitan Ram Manjhi by Nitish Kumar rocks Bihar assembly

Patna, Nov 10 (UNI) : Demanding resignation from Bihar Chief Minister Nitish Kumar for humiliating former Chief Minister Jitan Ram Manjhi, a Dalit leader on the floor of the house, the MLAs of National Democratic Alliance (NDA) created pandemonium following which the State Assembly was adjourned till lunch on Friday.

As the house assembled for the day and the speaker began question our proceedings, the BJP MLAs, the main opposition in the state assembly vented their anger on the issue and demanded resignation from the Bihar chief minister Nitish Kumar for humiliating a Dalit leader. The opposition members waving play cards and posters trooped to the well from where they continue to shout slogans against the chief

Minister Nitish Kumar. Meanwhile the ruling party members also trooped to the well carrying posters and banners with slogans written on it indirectly targeting the Prime Minister.

The speaker Awadh Bihari Chaudhary however continue the question hour proceedings amid ruckus. Chaudhary requested the members to resume their seats but the commotion continued for 16 minutes after which the house was adjourned till 2:00 p.m.

Later Jitan Ram Manjhi president of Hindustani Morcha along with NDA members staged dharna inside the Chamber of the speaker in protest against the remarks of the chief minister made on the floor of the House on Thursday regarding Manjhi whom Kumar had dubbed as a man of no use and it was his foolishness to make him CM in 2013.
