The original share certificates have been misplaced. I would therefore request you to issue duplicate certificate in the name of Mohan Miglani.

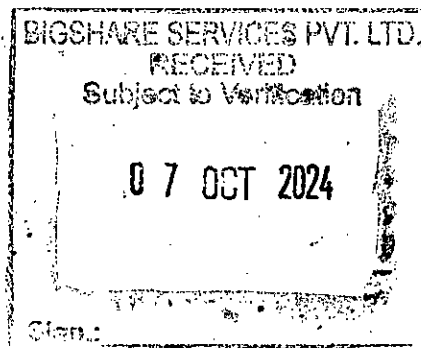

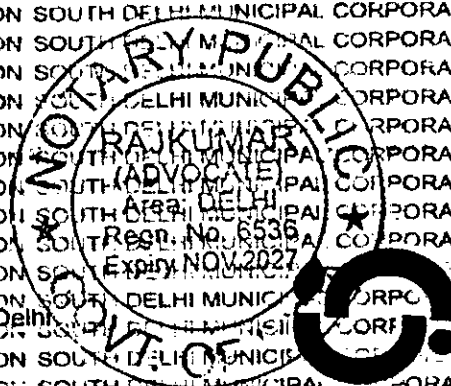

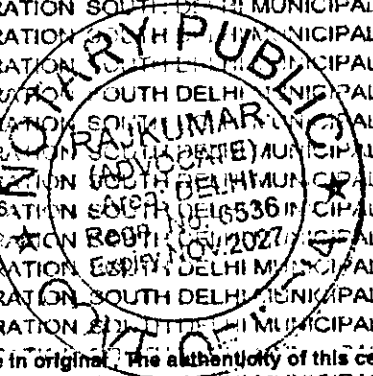
