SUB: Request for Reclassification from promoter group to public category pursuant to Regulation 31A of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015.

I, Sudha Rani Ganne, hereby inform you that I have been disclosed as a member of the "Promoter Group" of your Company as per Definition of Promoter Group in Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations 2018.
