Lupin Receives Approval from U.S. FDA for Fluocinolone Acetonide Body Oil

Mumbai, Baltimore, August 08, 2023: Global pharma major Lupin Limited (Lupin) today announced that its wholly-owned subsidiary, Novel Laboratories Inc., based in Somerset, New Jersey, has received approval from the United States Food and Drug Administration (U.S. FDA) for its Abbreviated New Drug Application for Fluocinolone Acetonide Oil, 0.01% (Body Oil), a generic equivalent of Derma-Smoothe/FS® 0.01% (Body Oil), of Hill Dermaceuticals, Inc. This product will be manufactured at Lupin's Somerset facility in the US.

Fluocinolone Acetonide Oil (RLD Derma-Smoothe/FS®) had estimated annual sales of USD 10 million in the U.S. (IQVIA MAT June 2023).
