Abolition of Slavery

Eradicating contemporary forms of slavery, such as trafficking in persons, sexual exploitation, the worst forms of child labour, forced marriage, and the forced recruitment of children for use in armed conflict. The abolition of slavery has been seen throughout history as a way to have all people be treated equal. Slavery, also known as enslavement, is the condition of being a slave. It is a practice where a group of people or a community of people are oppressed and are made to work as labourers without any remuneration. Slavery is a term that signifies the injustice that is being carried out against humans since the 1600s. The word "slave" is derived from the ethnic word "slav." It has derived in the English terminology from the old French word, "sclave" and Latin word "sclavus." Historians often find the use of the word "slave" and instead refer to the use of "unfree labourers" or "enslaved person." Whenever this word comes up, usually people picture rich white people ruling over black people. However, that is not

the only case to exist. Although modern slavery is not defined in law, it is used as an umbrella term covering practices such as forced labour, debt bondage, forced marriage, and human trafficking. After a profound study, historians found evidence that suggested the presence of slavery in almost every culture. It was not essentially in the form of people working in the fields, but other forms. Slavery generally happens due to the division of levels amongst humans in a society. It still exists in various parts of the world. It may not necessarily be that hard-core, nonetheless, it happens. Slavery was officially abolished in the United States on February 1, 1865. However, racial segregation continued throughout most of the following century and racism remains an important issue today. This year's Day of Remembrance pays particular tribute to the many women who suffered and died during the slave trade. They experienced appalling violence, including sexual and reproductive enslavement, forced prostitution, repeated sexual assault, as well as forced childbearing and the sale of their own children. Globally, one in ten children works. The majority of the child labour that occurs today is for economic exploitation. Slavery was abolished only because Britain no longer needed slavery in order to make money for the country. Slavery was abolished because people finally realised how barbaric it was

and how African people were not inferior to them. Slavery ended many lives and stole the future of successive generations. The descendants of those who were enslaved continue to face enduring social and economic inequality, intolerance, prejudice, racism, and discrimination. In 1807, Britain passed the first legislation banning slave trading and by 1815, the British pressured the Netherlands, France, Spain, and Portugal to do the same. Nearly 5 years later in 1820, the United States made slave trading punishable by the death penalty and to this day, selling, transporting, and owning slaves is considered one of the worst violations of human rights the world has ever experienced. The United States officially abolished slavery in 1865. Let us take collective action to reduce inequalities, eliminate racial discrimination, and end modern slavery. Today 40 million people are trapped in modern slavery. Children make up one quarter of these victims, while 71% of those enslaved are women. The onus is upon every Member State to eradicate trafficking, forced labour, servitude and slavery. None of us will be truly free whilst these people suffer. RTO inspectors' strike in the state is a blow to applicants

Surat, The Technical Officers Association of the Motor Vehicles Department of RTO across the state has started a movement as the pending issues are not resolved. Today, Monday, they have gone on strike with the 'No Login Day' campaign. The employees are protesting by not logging in to the office. Due to which all the operations have been disrupted and long queues have formed as the applicants are reaching the RTO office. However, after reaching here, people are being informed about the strike and are angry. Applicants who came to RTO offices including Ahmedabad, Surat, Vadodara and Rajkot for work after taking appointments were seen venting their anger as the work was not done. Applicants who had brought appointments were given a setback. Due to the no-login day, the applicants who were given appointments today had reached the RTO office since morning. Long queues had formed outside the RTO office as they were

not allowed to enter. All kinds of work was disrupted due to non-login. The applicants who came here expressed their anger after standing in line for two hours after learning about the strike. Applicants also troubled in Vadodara RTO. Protest was also registered at the Vadodara RTO office regarding the no login day. In which some applicants had reached the RTO office and we were shocked as we were not informed. Along with this, an estimated 300 more applicants who came here have been deprived of work today. At the same time, a total of 30 officers including inspectors, sub-inspectors and RTO officers in the Vadodara RTO office are supporting the applicants on the login day. If these officers go to Mass CL tomorrow too, the applicants may face more difficulties. 250 applicants face setback in Rajkot due to strike. Rajkot RTO Assistant Inspector Bhavesh Shingala said that the agitation has started on the issue of making 8 Assistant Inspectors of the 2018 batch, including 1 from

Rajkot, permanent after completing their probation and giving them promotions. In which all the employees have started working wearing black stripes, a black stripe poster has been placed in the DP of WhatsApp. Today, under the No Login Day campaign, not a single technical officer did his work. Today, the driving test track has also been closed, due to which around 250 applicants who had come to try for a two-wheeler or four-wheeler license have been requested to return. If the government does not satisfy the demand, then on February 11, the mass CL will come down on this matter and due to this, people's work will stop. While the applicant Kamlesh Shukla said that I am originally from Uttar Pradesh and I am working as a junior engineer in a company in Rajkot. I needed a two-wheeler license due to traveling and for that I had taken an appointment for a driving test a month ago. Today when I reached here, I was told that the RTO inspector has gone on strike due to which I will not be able to give the driving test today.

Another incident in Ahmedabad

Car driver rams 6 to 7 vehicles in Memnagar area, four people injured; Driver alleged to be drunk

Ahmedabad The havoc of speeding in Ahmedabad city is not stopping. A youth drove his car at a high speed in the Memnagar area of the city and hit 6 to 7 vehicles, injuring four people and sending them for treatment. The driver who caused the accident was caught by the people and handed over to the police. People alleged that the driver was in a drunken state. B Division police has conducted further investigation in this matter.

Early morning accident According to the information received, a car driver drove his car at a reckless speed on the road going from Vivekanand Circle in the Memnagar area of the city at around 7.45 am today. He hit more than two Activa bikes and three cars. A total of four people, including two elderly people and children, were also hit, due to which they suffered serious injuries. A crowd of people who were walking and children going to school had gathered early in the morning. An atmosphere of fear was created as the accident occurred on the 100-meter road, hitting vehicles and pedestrians.

People accused the driver of being drunk and caught the driver who caused the accident. According to many people, the driver was drunk. Two to three people were injured on the road, so people immediately ran to them. 108 was informed and they were shifted to the hospital for treatment. On the other hand, the police also reached the spot after being informed about the incident. The family of the driver who

caused the accident was informed and they also reached the spot. The serious accident also caused great anger among the people.

The police quickly arrested the driver and conducted further investigation. B Division Traffic Police immediately reached the spot and arrested the driver. According to the traffic police, the name of the driver of the accident has been revealed to be Chintan Mukeshbhai Parikh. The traffic police is currently taking legal action against the driver. Four people have been injured in the accident.

Blood samples were taken to know whether he was intoxicated or not - DCP

Police have arrested a youth named Chintan Parikh, who caused an accident in Memnagar area of Ahmedabad. Traffic DCP Neeta Desai said that the driver hit six vehicles on the way to Sola Cross Road, in which four people were injured and have been shifted to Asarwa Civil Hospital.

The police have started an investigation based on CCTV. Blood samples have been taken to report whether he was drunk or not. According to the driver, he had gone to drop his nephew to school. He has admitted that the accident happened when he stepped on the accelerator instead of the brake. He has been driving the car for years. We will check all the CCTVs on the road today to see what the speed of the car was. One of the injured is more serious, who has been shifted to Asarwa Civil Hospital for treatment.

Then SP Kuldeep Sharma sentenced to 3 months in prison

Bhuj Sessions Court verdict in 40-year-old case, Kutch Congress leader Ibhla Seth was beaten and humiliated, there was a complaint

Bhuj A complaint was filed against the late Mandhara Abdullah Haji Ibrahim, a prominent member of the Kutch Congress, 40 years ago today, alleging that the then police chief Kuldeep Sharma had insulted and abused him during a visit to the district police chief's office and had called a fellow officer and beaten him up. The hearing of this case finally reached its final stage yesterday (February 9). The verdict in this case was delivered today (February 10) in the Bhuj Sessions Court, in which



the accused were found guilty at the end of a very long court process in a 40-year-old case.

It was alleged that he went to meet the SP office and was beaten up.

The facts of this case are that Abdasa's Mandhara Abdullah Haji Ibrahim alias Ibhala Seth had come to meet the then MLA Kharashankar Joshi, Mandvi MLA Jaykumar Sanghvi, Gabhubha Jadeja, Shankar Govindji Joshi and other leaders at the SP office in connection with the case registered in Naliya. During this, it was alleged that the then SP Kuldeep Sharma insulted him, abused him, called his fellow officers and beat him up. In this regard, when Ibhala Seth was injured at that time, Shankar Govindji Joshi, who came with him in the delegation, stopped Kutch's advocate M.B. Sardar

and filed a complaint against the SP and four accused in the Chief Judicial Court of Bhuj.

After the final hearing was completed on January 28, in the year 2020, after the death of the plaintiff's lawyer M.B. Sardar, R.S. Gadhvi appeared as the lead advocate of the plaintiff in this case. Earlier, there were four accused in this case, out of which B.N. Chauhan and P.S. Bishnoi died during the ongoing proceedings, while the other two accused Kuldeep Sharma and Girish Vasavada were charged in the Additional Chief Court. After the statement of the accused, the final hearing was completed on January 28. And the case has come to the judgment on February 10 today after 40 years. In this case, R.S. Gadhvi argued on behalf of Ibhala Seth's side and the original plaintiff.

દિલ્હીમાં મત ગણતરીના પ્રારંભિક વલણોમાં ભાજપ જીત તરફ આગળ વધી રહ્યું છે. અંદાજે ૨૭ વર્ષ બાદ દિલ્હીની સત્તા પર ભાજપની શાનદાર એન્ટ્રી થઈ છે. આ દરમિયાન હવે એ સવાલ પર ચર્ચાએ જોર પકડ્યું છે કે દિલ્હીના આગામી મુખ્યમંત્રી કોણ હશે? દિલ્હીમાં ૨૭ વર્ષનો દુઃખાળ સમાપ્ત થયા બાદ ભાજપ રાજધાનીની કમાન કોને સોંપશે? આ રેસમાં ઘણા દિગ્ગજોના નામ આગળ આવી રહ્યા છે. ચૂંટણી દરમિયાન પ્રવેશ સાહિબ સિંહ વર્મા જેવા નેતાઓના નામો જ નહીં પરંતુ દિલ્હીના પ્રાદેશિક રાજકારણમાં મોટું નામ એવા મનોજ તિવારી જેવા નામો પણ ચર્ચાઈ રહ્યા છે. જો કે, લાંબી યાદીમાં AAP (AAP) છોડીને ભાજપમાં જોડાનારા ઘણા નેતાઓના નામ પણ દેખાઈ રહ્યા છે. ભાજપની આ જીતમાં મહિલા મતદારોનો મોટો ફાળો હોવાનું પણ ચર્ચાઈ રહ્યું છે. આવી સ્થિતિમાં મુખ્યમંત્રી પદ મહિલા નેતાના ખાતામાં જઈ શકે છે. પાર્ટીએ સુખ્યા સ્વરાજના રૂપમાં મહિલા મુખ્યમંત્રી આપ્યા હતા. આ વખતે તેમની ટિકરી બાંસુરી સ્વરાજનું નામ સામેલ કરવામાં આવ્યું છે. સ્મૃતિ ઈરાની અને મીનાશી લેખીને પણ મુખ્યમંત્રી બનાવવામાં આવી શકે છે.

જો પ્રવેશ વર્માની વાત કરીએ તો સૌથી મોટું કારણ એ છે કે બીજેપીએ તેમને નવી દિલ્હી સીટ પરથી અરવિંદ કેશરીવાલ સામે મેદાનમાં ઉતાર્યા હતા. પૂર્વ સોમનાથ સાલિંગ સિંહ વર્માના પુત્ર મહેન્દ્રવીથી બે વખત સાંસદ અને ધારાસભ્ય રહી ચૂક્યા છે. કાલકાજમાંથી દિલ્હીના મુખ્યમંત્રી આતિથીને પડકારનાર ભાજપના પૂર્વ સાંસદ રમેશ બિપુરીનું નામ પણ ચર્ચામાં છે.

દિલ્હી ભાજપના પૂર્વ અધ્યક્ષ મનોજ તિવારી સતત ત્રીજા વખત ઉત્તર-પૂર્વ દિલ્હીથી સાંસદ તરીકે ચૂંટાયા છે. આ વખતે ભાજપે દિલ્હીની સાતમાંથી છ લોકસભા બેઠકો પર તેના ઉમેદવારો બદલ્યા હતા, પરંતુ મનોજ તિવારીની ટિકિટ રદ કરવામાં આવી ન હતી.
