

In terms of Regulation 30 and other applicable provisions of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we would like to inform you that vide letter dated 06th August 2016, the company had intimated to the stock exchange that the company had commenced its commercial production with a production capacity of 80,000 Bulk Litre per day on 01st August 2016 at its unit, M/s Globus Spirits Limited, Vill : Dhudhua, Tehsil : Jandaha, Dist:Vaishali, Bihar. In this regard we would like to further inform you that after producing 25000 Litre of alcohol since its commencement on 1st August 2016, for setting right certain technical matters, the plant needed to temporarily closed. Consequently, due to severe flooding at factory premises (previously intimated to exchanges vide letter dated 14 September, 2016) the disruptions compounded. In the meanwhile the office of Industry Department also visited to our site and they were of the view that 01st August 2016 could not be considered as the date of commercial production since the factory was barely under operation. Now all the bottlenecks are removed and plant will be restarting in the current month however the date of commercial production will be intimated after getting confirmation from the Industry Department, Govt. of Bihar.
