Review Report

To The Board of Directors

Atlas Cycles (Haryana) Limited.

We have reviewed the accompanying statement of un-audited financial results of Atlas Cycles (Haryana) Limited ("the Company") for the quarter ended 30th June, 2016 ("the statement") being submitted by the company pursuant to the requirements of clause 41 of the listing Agreement with Stock Exchanges except for the disclosures regarding "Public Shareholding" and "Promotor and Promotor Group Shareholding" which have been traced from the disclosures made by the management and have not been reviewed by us. This standard requires that we plan and perform the review to obtain moderate assurance as to whether the financial statements are free of material misstatement. A review is limited primarily to inquire of Company personnel and analytical procedures applied to financial data and thus provide less assurance than an audit and according, we do not express an audit opinion.

Based on our review conducted as above, nothing has come to our attention that causes us to believe that the accompanying statement of unaudited financial results prepared in accordance with recognition and measurement principles laid down in Accounting Standard AS-25 'Interim Financial Reporting' notified pursuant to the Companies (Accounting Standards) Rules, 2006 (as amended) and other recognized practices and policies has not disclosed the information required to be disclosed in terms of Clause 41 of the Listing Agreement including the manner in which it is to be disclosed, or that it contains any material misstatement.
