Subject: Clarification /confirmation on the news item appearing in www.cnbctv18.com

This is with reference to the e-mail received from BSE bearing reference no. L/SURV/ONL/RV/AA/(2025-2026)/ 3 and the letter received from NSE, bearing reference no. NSE/CM/Surveillance/15344, both dated April 16, 2025, seeking clarification/confirmation on the news item appeared on "www.cnbctv18.com" dated April 16, 2025 captioned "Lupin, Zydus Life shares fall up to 5% as US court sides with Astellas in Myrbetriq patent case". In this regard we would like to state as under:

1. We confirm that the United States District Court for the District of Delaware has passed an order in the matter of Myrbetriq patent case.

We refer to our intimation dated May 10, 2024, in which we had intimated about lifting of the temporary restraining order passed by the US Court and denied Astellas' request for a preliminary injunction on Mirabegron ER Tablets and accordingly the shipment of the product was resumed. The management in consultation with the lawyers at that time assessed the risk as a remote risk and accordingly since the said event was not material as defined under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, ('Listing Regulations') the same was not disclosed to the Stock Exchanges.

2. Other than the captioned matter, the Company is not aware of any information that has not been announced to the Stock Exchanges which could explain the movement in the trading. The Company is in the process of intimating the information of the above-said US Court order to the Stock Exchanges within the timelines prescribed under the Listing Regulations.
3. The Company is in the process of assessing the impact and will update the same to the Stock Exchanges.
