Declaration of Voting Results in respect of Shareholders' Resolution passed on May 8, 2025

In terms of Section 110 of the Companies Act, 2013 read with Rules 20 & 22 of the Companies (Management and Administration) Rules, 2014 read with General Circular No. 09/2024 dated September 19, 2024 and the previous circulars related to relaxations issued by Ministry of Corporate Affairs (MCA) applicable in this regard, IDBI Bank provided facility of e-voting to the Members vide Bank's Postal Ballot Notice dated April 04, 2025 sent only through electronic mode on April 08, 2025 to those Members whose e-mail addresses were registered with the Bank/Depositories on April 04, 2025 towards passing 3(three) Resolutions for (i) Re-appointment of Shri Rakesh Sharma (DIN: 06846594) as Managing Director & Chief Executive officer of the Bank for a period of three years w.e.f. March 19, 2025, as approved by the RBI; (ii) Appointment of Shri Sat Pal Bhanoo (DIN: 10482731) as LIC Nominee Director, liable to retire by rotation, on the Board of the Bank, w.e.f. February 10, 2025 and (iii) Appointment of Shri R. Doraiswamy (DIN: 10358884) as LIC Nominee Director, liable to retire by rotation, on the Board of the Bank, w.e.f. May 19, 2025.

Members voted exclusively through e-voting from Wednesday, April 09, 2025 at 9 a.m (IST) to Thursday, May 08, 2025 at 5.00 p.m. (IST), being the last date specified for voting. The Board had appointed Ms. Aparna Gadgil of M/s. S.N Ananthasubramanian & Co. as Scrutinizer to scrutinize the votes cast through e-voting. Scrutinizer submitted her Report of the total votes cast in favour or against the Resolutions, in terms of the said Rule 20 of the Companies (Management and Administration) Rules, 2014.

We are pleased to present the report on the Postal Ballot conducted by **IDBI Bank Limited** ("the Bank") seeking consent of its Members for the Ordinary Resolutions as contained in the Notice of Postal Ballot dated **April 04, 2025**.

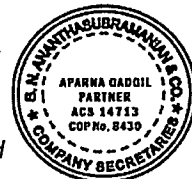
1. In terms of provisions of Section 110 of the Companies Act, 2013 ("the Act") read with Companies (Management and Administration) Rules, 2014, we were appointed as the Scrutinizer by the Bank on **March 26, 2025** to conduct the Postal Ballot as contained in the Notice, dated **April 04, 2025** ("Postal Ballot Notice").
2. In terms of Sections 110 and 108 of the Companies Act, 2013, and all other applicable provisions, if any, of the Act read with Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014 and in accordance with the relevant circulars issued by Ministry of Corporate Affairs ("MCA") from time to time, in relation to *inter-alia* "Clarification on passing of Ordinary and Special resolutions by companies under the Companies Act, 2013" read with rules made thereunder, Members' approval was sought for the Ordinary Resolutions as contained in the Postal Ballot Notice through e-voting only.

3. Notice of the Postal Ballot

- 3.1. The Bank has informed that, on the basis of the Register of Members and the List of Beneficial Owners made available by the Depositories viz., National Securities Depository Limited ("NSDL") and Central Depository Services (India) Limited, as on **Friday, April 04, 2025 ("the cut-off date")**, the Bank had completed the dispatch of Postal Ballot Notice on **April 08, 2025** through e-mail to **6,81,276** Members who had registered their email-ids with the Bank/ Depositories/ Depository Participants/ Registrar and Share Transfer Agent.
- 3.2. The Bank had hosted the Postal Ballot Notice on its website and the website of KFin Technologies Limited (e-voting Agency) and also intimated the same to BSE Limited and National Stock Exchange of India Limited on **April 08, 2025**.

- 3.3. Pursuant to Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014 and the relevant MCA Circulars, an advertisement regarding the Postal Ballot was published on **April 09, 2025** in all editions of **Financial Express (English Newspaper) and Loksatta (Marathi Newspaper)**.
4. In terms of the aforesaid notice, Members were required to convey their assent or dissent, only through e-voting system, on e-voting platform provided by KFin Technologies Limited (KFintech) from **09:00 a.m. (IST) on Wednesday, April 09, 2025, till 05:00 p.m. (IST) on Thursday, May 08, 2025**.
5. Members' demographic details and voting rights and voting pattern thereafter were downloaded by us from the e-voting platform provided by KFintech.
6. After the scrutiny of the votes cast, all the votes cast by the Members were found to be valid;
7. Pursuant to Section 12(2) of the Banking Regulation Act, 1949, the voting rights of person(s) holding shares in excess of 26% have to be capped at 26% of total voting rights of all Shareholders of the Bank. Accordingly, we have capped the valid votes cast by Government Of India and Life Insurance Corporation of India each to 26% of total voting rights of all Shareholders of the Bank
8. We report that the 03 (Three) Ordinary Resolutions as contained in the Postal Ballot Notice has been passed with requisite majority.
