4. Original cancelled cheque leaf bearing the name of the first holder, failing first security holder is required to submit copy of bank passbook / statement duly attested by the bank which is mandatory for registering the new bank details

Note: If your folio is already KYC compliant, a simple request letter duly signed by all shareholders will suffice.

For shareholders holding shares in Demat mode, please submit:

1. Request letter
2. Client Master List (CML) copy
3. Cancelled cheque leaf

Please note that the unpaid dividend for the **Financial Year 2017-2018** is scheduled to be transferred to the IEPF on **02/12/2025**. Accordingly, your request for claiming this dividend should reach us or the RTA **on or before 15/11/2025**.
