Sub: Outcome / Intimation under Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended (“Listing Regulations”)

We wish to inform you that Vedant Fashions Limited (“the Company”) received a Seizure Memo dated *December 16, 2025*, from the Senior Inspector, Department of Legal Metrology (Weight & Measures), Lahurabir, Varanasi, Uttar Pradesh, 221007 (“the Authority”), citing an alleged violation under Section 36(1) of the Legal Metrology Act, 2009 (“the Act”) and Rule 9 of the Legal Metrology (Packaged Commodities) Rules, 2011 (“the Rules”), which pertain to non-disclosure of the size on the product label, observed during an inspection at one of the retail outlets.

In response to this, the Company submitted a request dated *February 20, 2026*, seeking compounding of the offence with a minimum applicable fee. Subsequently, the Authority issued a Notice on *March 17, 2026*, directing the Company to deposit an amount of ₹ 50,000/- (Indian Rupees Fifty Thousand only) as compounding fee, along with the method of compounding. The Company has duly complied with the directive by depositing the compounding fee on *March 24, 2026*, and has formally informed the Authority through a letter dated *March 25, 2026*.

The requisite details pursuant to Regulation 30 of the Listing Regulations are shared below:

1. Name of the Authority – **Office of the Senior Inspector, Department of Legal Metrology (Weight & Measures), Lahurabir, Varanasi, Uttar Pradesh, 221007**
2. Nature and details of the action(s) taken, initiated or order(s) passed – **Compounding fee (₹ 50,000/-) determined by the authority for non-disclosure of the size of the item on label of the product (being Pocket Square)**
3. Date of receipt of the direction or order, including any ad-interim or interim orders, or any other communication from the authority – **March 25, 2026 at 16.10 hours**
4. Details of the violation(s)/contravention(s) committed or alleged to be committed – **Non-declaration of the size of the item on the product label, which are in violation under the Act and the Rules.**
5. Impact on the financial, operation or other activities of the listed entity, quantifiable in monetary terms to the extent possible – **Except the amount mentioned above, there is no other impact on the financial or operation of the Company.**

We request you to kindly take the aforesaid information on record and disseminate the same on your respective websites.
