**Sub: Disclosure under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 – Show cause Notice for E-Adjudication for defaults under Section 137(3) of the Companies Act, 2013**

This is to inform you that pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we would like to inform that the Company had suo-moto filed an application for adjudication in relation to the non-filing of AOC-4 CFS under section 137 (3) of the Companies Act, 2013, the Company was required to file the AOC-4 CFS, whereas the company has filed only AOC-4.

Accordingly, the Company has now received the Show Cause Notice dated 22<sup>nd</sup> April, 2026 issued by the Registrar of Companies, ROC Delhi I and the penalty has been imposed to the Company and officer in default for completion of the process of Adjudication.

The Company has now received a Show Cause Notice dated April 22, 2026 issued by Registrar of Companies – ROC, Delhi I, for adjudication. The penalty imposed on the company is Rs. 53,400/- (Rupees Fifty-Three Thousand and Four Hundred). Further, a penalty of Rs. 50,000/- (Rupees Fifty Thousand) on Ms. Sonika Aggarwal, Director and Rs. 50,000/- (Rupees Fifty Thousand) on Ms. Monicca
