**Sub:** Clarification from Mason Infratech Limited for the half year ended 30-Sep-2025 with respect to Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

**Remarks:** The figures of Standalone and Consolidated financial results are similar; thus, the Company is requested to provide a clarification/rationale on the same.

**The Company is pleased to inform that Mason Infratech Limited, in its financial results for the half year ended September 30, 2025, approved on November 12, 2025, has disclosed the following observations in the Limited Review Report issued by the Statutory Auditors:**

**Associate Entities**

1. **Ekkam Infra Build LLP**
2. **Milestone Projects and Developers Private Limited**
3. **Megastone Projects Private Limited**

Based on the review conducted, the Statutory Auditors have stated that **nothing has come to their attention that causes them to believe that the accompanying financial statements**, prepared in accordance with the recognition and measurement principles laid down under **Section 133 of the Companies Act, 2013**, read with the relevant rules and other accounting principles generally accepted in India, **do not disclose the information required under the Listing Regulations or contain any material misstatement.**

The consolidated financial statements include the financial results of **Ekkam Infra Build LLP**, in which the Company holds a **30% stake**. For the period ended **September 30, 2025**, Ekkam Infra Build LLP reported a **loss of ₹86,183/-**, of which the Company’s share of loss amounting to **₹25,855/-** has been appropriately adjusted against the investment in Ekkam Infra Build LLP in the Company’s financial results.

Further, the consolidated financial statements include the financial results of **Milestone Projects and Developers Private Limited**, in which the Company holds a **30% equity stake**. For the period ended

**September 30, 2025**, the said entity reported **neither profit nor loss**, and accordingly, there was **no financial impact** on the Company's consolidated results for the said period.

The consolidated financial statements also include the financial results of **Megastone Projects Private Limited**, in which the Company holds a **50% equity stake**. For the period ended **September 30, 2025**, this entity likewise reported **neither profit nor loss**, resulting in **no financial impact** on the Company's consolidated results.

**Accordingly, the figures reported in the Standalone and Consolidated Financial Results of the Company for the said period are identical.**

Therefore, we kindly request you consider and approve the Standalone & Consolidated financials of September 30, 2025.
