**Sub: Update on Ongoing Litigation - Intimation under Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015**

Dear Sir,

We refer to our intimation dated 27<sup>th</sup> August, 2025, wherein the Company, pursuant to Regulation 30 read with clause 20 Para A of Part A of Schedule III of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, had informed that Office-Joint Commissioner (Corporate Cell) S.G.S.T. Office, Meerut, Uttar Pradesh had issued a notice alleging double e-way bill generated on an invoice (total 3 case) and imposed liability of Rs.1,22,415/- on Nanglamal Sugar Complex(NSC), Nanglamal, a unit of the Company.

In this regard, it is informed that the Company challenged above liability by filing a representation before the Office of the Joint Commissioner of (Corporate Cell) S.G.S.T. Office, Meerut, Uttar Pradesh. After considering the representation filed by the Company the Hon'ble Joint Commissioner has been pleased to cancel the said liability.


