This is with reference to your e-mail seeking clarification regarding the non-submission of segment details in the financial results of Mayasheel Ventures Limited submitted to the Exchange on 26 May 2026.

1. Segment Reporting

We wish to submit that the Company is engaged in a single line of business, namely Engineering, Procurement and Construction (EPC) of roads, highways and other infrastructure projects, which constitutes a single reportable operating segment.

Accordingly, in terms of the requirements of Indian Accounting Standard (Ind AS) 108 – Operating Segments, the Company is not required to disclose separate segment-wise financial information, as there is only one reportable operating segment.

Further, all the non-current operating assets of the Company are located in India and the Company does not have any reportable geographical segments requiring separate disclosure.

The above accounting treatment and non-disclosure of separate segment information have been adopted based on the advice and confirmation of the Statutory Auditors of the Company.
