Pursuant to Regulation 30 of SEBI (LODR) Regulations, 2015, we wish to inform you that operations of one of the manufacturing plants of the Company situated at Dhodsar are partially affected due to stoppage of production in one (1) coating line, in view of strike called by the Contractual Workers w.e.f. 09th May, 2026. However, the other manufacturing plants of the Company are fully operational.

The Company is in continuous discussion with the concerned workers and contactors to resolve the issue amicably as soon as possible and will provide update on further developments in due course.

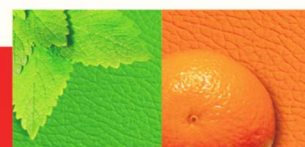
