**Sub: Disclosure of event or information under Regulation 30 of SEBI (LODR) Regulations, 2015**

In terms of the subject referred regulations read with Para A of Part A of Schedule III thereof, this is to inform that the Company has received on 11<sup>th</sup> December 2025, a Notice from Employees Provident Fund Organization, Ranchi, relating to Section 14B & 7Q of the EPF & MP Act, 1952 in which the Company is directed to deposit the assessed amount of Rs. 9.60 crores.

The subject matter of the Notice originated at the time when the Company was under Corporate Insolvency Resolution Process ("CIRP") and therefore under the then Resolution Professional. Upon the new Promoter taking over, information/regulatory gaps during the CIRP tenure were being progressively identified and systemically addressed. The impugned Notice now identified is amongst them. Having identified the alleged inconsistency supposedly on the part of the Company, it is now aggressively engaged in appropriately addressing the issue. This will be initially done through close liaison with the PF authorities. Should such follow-up reveal no shortcomings on the part of the Company, the matter will be taken up legally. The authenticity as well as sustainability of the alleged claim, given that such alleged claim on which hitherto no action has been taken by those in charge of administering the Company during CIRP, has only now been discovered and the Company is evaluating the Notice for exercising the right to appeal with higher authorities and will take necessary actions as required to comply with the directives mentioned therein.

We will keep the Stock Exchange informed of any material developments arising from this Notice in accordance with the regulatory requirements.
