As part of the said agility program and subject to receipt of necessary statutory approvals, the company intends to transfer the excise license issued by Telangana Prohibition & Excise Department to another party, following which our factory operations at the Unit will cease.</p> <p>Above information was intimated to the Officer of the Company at around 15:00 hrs IST on 3rd June 2026. Delay in disclosure was due to the time needed for verification of facts and information with multiple internal stakeholders.</p>
