1	Name of the Authority(ies)	Office of Sub-Divisional Officer, Dindori, Nashik.
2	Nature and details of action(s) taken or order(s) passed	Pursuant to the Company's <i>suo-motu</i> regularization application, the Office of Sub-Divisional Officer, Dindori, Nashik has issued an advisory letter on 28 <sup>th</sup> August 2025 to Tehsildar, Dindori, Nashik fixing the quantum of fee for the said regularization.
3	Date of receipt of direction or order, including any ad-interim or interim orders, or any other communication from the authority	An advisory letter/ communication has been issued by the Office of Sub-Divisional Officer, Dindori, Nashik to Tehsildar, Dindori, Nashik on 28 <sup>th</sup> August 2025 <i>inter-alia</i> requiring the Company to pay a regularisation fee of ~INR 5.81 crore, which has been duly paid on 8 <sup>th</sup> October 2025.  There has been a short delay in disclosure due to the time needed for discussion with the Tehsildar and verification of facts and information with multiple internal stakeholders.
4	Details of violation(s)/ contravention(s) committed or alleged to be committed	In December 2022, the Company <i>suo-motu</i> initiated regularisation of construction on Company's own land located at manufacturing facility in Nashik, in accordance with the provisions of Maharashtra Land Revenue Code, 1966, and Maharashtra Regional and Town Planning Act, 1966. The Company has received advisory to pay regularisation fee.
5	Impact on financial, operation or other activities of the listed entity, quantifiable in monetary terms to the extent possible	Apart from the payment of the regularization amount there is no financial impact on operations of the Company due to the said imposition of the regularization fee.
