ANNEXURE-I

SUMMARY OF THE NATIONAL COMPANY LAW TRIBUNAL ("NCLT") CONVENED MEETING OF THE UNSECURED CREDITORS OF THE COMPANY

1. Pursuant to the NCLT Order dated June 12, 2026 ("**NCLT Order**"), directed to convene a meeting of the unsecured creditors of the Company, which was held today i.e., Monday, 3d August, 2026, at 04:00 pm IST through Video Conferencing, to consider and approve, the Scheme of Amalgamation.
2. Mr. Ganapathy Mala Joshy was appointed as the Chairperson for the Meeting vide the NCLT Order, and M/s Padekar and Kulkarni, Company Secretaries, was appointed as the Scrutinizer for the e-voting process.
3. Mr. Ganapathy Mala Joshy chaired the meeting and, upon confirmation that the requisite quorum is present, conducted its proceedings.
4. The presence of Directors, Key Managerial Personnel and Unsecured Creditors was recorded at the Meeting.
5. Remote e-voting was open from 09.00 am on 31st July, 2026, to 05.00 pm on 2nd August, 2026, and was also open during the meeting until 15 minutes after the completion of proceedings of the meeting.
6. The Scheme of Amalgamation of Master Moulds Private Limited ("**Transferor Company**") with Master Components Limited ("**Transferee Company**") and their shareholders and creditors under section 230 and 232 of the Companies Act, 2013 as set out in the Notice of NCLT Convened Meeting of Unsecured Creditors have been approved with requisite majority, as prescribed under Sections 230 to 232 of the Companies Act, 2013.
7. The Scheme of Amalgamation has also been approved by the majority of Unsecured Creditors.
8. The result of remote e-voting and e-voting shall be uploaded on the website of the Company, NDSL and Stock Exchanges (NSE).
9. Post conclusion of the voting lines, the Scrutinizer submitted the report to Mr. Ganapathi Joshy, NCLT appointed chairperson of the meeting, who is authorised to receive it and Scrutinizer's report shall be submitted to the stock exchange as well hosted on the website of the company
10. After proposing the vote of thanks, the Meeting was declared as concluded with the permission of the Chair.

The Company Secretary concluded the meeting as at 04.17 pm and requested to the Unsecured Creditors to cast their votes within a time slot.
