Re: Scrutinizers' Report on Postal Ballot held through remote E-voting in respect of passing of resolution set out in the notice dated July 10, 2026 pursuant to section 108 & 110 of the Companies Act, 2013 read with Rule 20 & 22 of the Companies (Management and Administration) Rules, 2014

1. I, Ranjit Kumar Singh, Proprietor of M/s RANJIT & ASSOCIATES, Practising Company Secretaries, having office at C-203, Ved Residency-II, Old Bapod Jakat Naka, Waghodia Road, Vadodara 390019 have been appointed as Scrutinizer by the Board of Directors at its meeting held on May 19, 2026, pursuant to Section 108 & 110 of the Companies Act, 2013 read with Rule 20 & 22 of the Companies (Management and Administration) Rules 2014 (herein after referred to as Rules) for scrutinizing the Postal Ballot held through remote e-voting process, in respect of resolution contained in the Postal Ballot Notice dated July 10, 2026 ('the Postal Ballot Notice').
2.  - A. Notice of Postal Ballot was transmitted to the members of the Company on July 10, 2026, only to those members whose e-mail ids were registered with the Company / Depositories, as on July 03, 2026, which was cut off date for sending Postal Ballot Notice.
 - B. The above notice was intimated to the National Stock Exchange of India Limited on July 10, 2026 and also placed on the website of the Company (www.madhavcopper.com) forthwith when it was sent to members.
 - C. The notice clearly indicated the process and manner for electronic voting during the remote e-voting period and also provided instructions for the login ID and generating password and casting of vote in a secured manner.



- D. As per requirement of the Companies (Management and Administration) Rules, 2014, the public advertisement with respect to dispatch of postal ballot notice and intimating date and time of commencement and closing of remote E-voting have been published in English language in Financial Express Newspaper and in regional language in Sandesh Newspaper on July 11, 2026.
- E. The remote e-voting period remained open from Monday, July 13, 2026 (9.00 A.M. IST) to Tuesday, August 11, 2026 (5.00 P.M. IST).
- F. The members of the Company holding shares as on "Cut-off" date i.e. July 03, 2026 were entitled to vote on the resolution mentioned in the notice of aforesaid Postal Ballot.

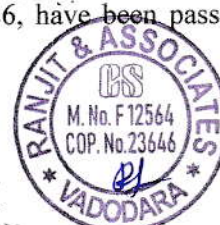

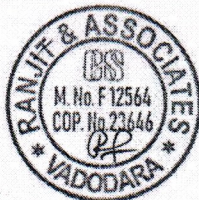
