With reference to our letter dated February 19, 2025, and pursuant to Reg. 30(7), we would like to inform you that the Central Government Industrial Tribunal (CGIT), Maharashtra, in the matter of Optival Health Solutions Private Limited (Subsidiary Company) (Appellant) vs. Regional Provident Commissioner-EPFO, Pune (Respondent), has issued an order on March 11, 2025.

As per the order, the Regional PF Commissioner-I, Pune-I (Respondent) has been directed to maintain the status quo as of today until further order passed in the matter.
