During the course of the refinancing transaction and in the interim period, the pledge of shares by the existing promoter group, as stated above, will temporarily increase from 23.91% to 27.96%. Upon successful completion of the debt refinancing and the consequent release of the existing pledged shares by the existing lender, upon receipt of payment in accordance with the agreed terms, the aggregate promoter group share pledge is expected to reduce to 24.48%
