With reference to captioned subject, this is to submit that the company had filed a Disclosure under Regulation 30 (2) of SEBI LODR Regulation read with Clause 20 of Part A of Part A of Schedule III of the LODR regulations regarding receipt of a notice from Market Committee, Rupnagar in the matter of alleged non payment of Market Committee Fee and RDF Fee by the company.

This revised disclosure pertains to correction of an unintentional error in the amount of Market Committee Fee and RDF Fee raised in the said notice. The original disclosure stated the amounts as Rs. 36,568,59,110/- instead of Rs. 36,68,59,110/- for both Market Committee Fee and RDF Fee.

The notice dated 09.04.2026 was received by the Company on 13.04.2026, and the disclosure u/s 30 was filed within the prescribed time period.
